on Deferred Gifts**

Mr. and Mrs. D made a gift of \$4,000 to OU under the Guaranteed Life Income Plan. We refer to this type of gift as being deferred because the University of Oklahoma will not receive the beneficial interest from the gift until it has served the D's for their lifetimes.

Mr. D. will receive \$280 per year for as long as he lives. The amount of the return is determined by the age of Mr. and Mrs. D when the gift is made. Should Mrs. D survive her husband she will receive the same amount for her lifetime. Of the \$280 which the D's will receive annually only \$57.15 is subject to federal income tax. Also, on their 1969 income tax return the D's may claim a charitable contribution deduction of \$1771.48.

Mr. and Mrs. D have designated that after their lifetimes the beneficial interest be made available for scholarships in the School of Music.
