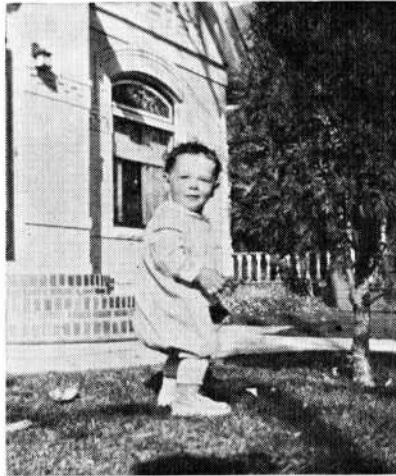

MRS MARY HART TROSPER

Mrs Mary Hart Trosper, '23 arts-sc., wife of Ray Trosper, '19 arts-sc., '24 law, Oklahoma City lawyer, was overcome with carbon monoxide fumes Saturday, December 27. She was found in her garage, having attempted to start her automobile. Mrs Trosper was a member of Alpha Phi fraternity.

SYDNEY RITCHEY

Sydney Ritchey, '33 law, of Kingston, died December 25 at Norman, as the result of gas fumes. Mr Ritchey was found lying on his bed near death as a result of asphyxiation. He had been unconscious for practically twelve hours when found. Mr Ritchey was a member of Delta Chi fraternity.

ZEXIE AND JESSIE GRIFFITH

Miss Zexie Ola Griffith, '24 home ec., head of the home economics department of the Connors State School of Agriculture at Warner, and her sister, Miss Jessie Trula Griffith, '28 fine arts, supervisor of music in the Norman public schools, were murdered Sunday morning, December 28, near Tonkawa, Oklahoma. Both had spent Christmas with their parents residing in Blackwell. Originally planning to return home Saturday night, they remained over so that they might have dinner with the family. They started for home, driving in Miss Jessie's car, at five o'clock Sunday morning. At nine o'clock, hunters found the bodies near the road, about a hundred yards apart, near the banks of the Salt Fork of the Arkansas river. Miss Jessie had been shot apparently after being thrown from the car, as she was lying with one hand under her head. Both girls had been shot through the head, and the bullet fired at Miss

Jessie passed through the head and hand. There was evidence of a terrific struggle. Various individuals and organizations, contributed to a reward fund for the murderer. A suspect was named and a search throughout the southwest began for him.

1907

Carl H. Statuary they purchased in Italy is to be placed in the park. Trees and shrubs are now being planned. Entrance to the house will be by a winding drive which circles a lake on the estate. Included in the house will be an art gallery to house the Buttram's fine art collection.

Mr Walker objected to the appointment of a man to a post by the commission, whom he did not consider qualified.

He stated, however, that he was opposed to proration as now enforced and would support revisionary legislation.
