

The Annual Election

FIVE new members to the Alumni association executive board will be elected by active members of the association through a mail ballot during the next month.

Ballots were to be sent out early in April for the selection of board members from districts two, four and seven and at large.

A. N. "Jack" Boatman, Okmulgee attorney, is the retiring member from district two. Ben Hatcher, Ada attorney, is retiring from district four, and George A. Meacham, Clinton attorney, has served his term from district seven.

Mrs. Walter Ferguson, Tulsa columnist, and John Rogers, Tulsa attorney, have completed terms from at large.

Candidates to fill these vacancies were selected by a nominating committee. Six were chosen to run for the two positions to be named at large and three candidates were picked to run for each of the district positions.

Two-thirds of the board members will stay in office under the association regulations that provide for a turn-over of one-third of the board each year.

The board will meet on the campus during commencement time early in June. New officers will be named and plans made for Homecoming and alumni activities of the coming school year.

CLAREL B. MAPES, B.S. in C.E.'22, B.A.'23, M.A.'26, Oil and Gas Association Secretary, Tulsa. General secretary-treasurer of the Mid-Continent Oil and Gas association; Secretary-treasurer of the Oklahoma Petroleum Industries committee; Secretary-treasurer of the Osage Oil and Gas Lessees association; Formerly engineer and executive for a half dozen large corporations; Member of seven professional societies; Officer, Infantry—Reserve, 190th Infantry Brigade; Member of Phi Beta Kappa, Sigma Tau and Scabbard and Blade; Member of the Masonic Lodge and a half dozen Tulsa clubs; Life Member (2-5-0) Stadium-Union Memorial Fund.

Assistant to the Division Manager of the Oklahoma Gas and Electric company; "Dad" Order of De Molay; Reception committee chairman, Ardmore Chamber of Commerce; Chairman Troop organization committee, Boy Scouts; Member executive committee, Sea Scouts; American Legion; Life Member of this association; Former director of the Oklahoma City Chamber of Commerce; Former vice-president of the Oklahoma Junior Chamber of Commerce; Former vice-president of the Oklahoma City O. U. Alumni association; voice is known to thousands of O. U. football fans as announcer for public address system at Sooner football games and for WNAD at football and basketball games; Life Member (2-5-0) Stadium Union Memorial Fund; Member of Phi Alpha Delta, Jazz Hounds and Checkmate.
