She came to Norman from Edmond, where she was connected with Central State Teachers college, and had taught in high schools in Oklahoma, Iowa and Washington. She held bachelor and master degrees in education from Iowa State Teachers college, Cedar Falls, Iowa; and Ph.B. and M.A. degrees in history from the University of Chicago.

Cy Everett, Jr., '36ex, was found dead at his home in Tulsa, October 14. A gunshot wound in his head apparently was self-inflicted, investigating officers reported. The body was found inside a closed closet after the family missed the youth at breakfast time.

Mrs. Pauline Goodson Cullison, '30as, died August 26 at Blackwell after an illness of two weeks. She was a member of Alpha Chi Omega sorority, and was chapter president in 1929-30. She is survived by her husband, who is an attorney in Blackwell, one son, William Eugene, and her mother, Mrs. Ola Goodson. She was the daughter of a pioneer family which settled near Blackwell at the opening of the Cherokee outlet in 1893.

Mary Bounds, home economics sophomore last year, died August 26 at her home in Davis. Miss Bounds was chosen the healthiest 4-H club girl in Oklahoma in 1934, and placed second in a national health contest at Chicago.

YEAR BY YEAR

1910

Frank Buttram, '10as, '12M.A., Oklahoma City oil man, was general chairman in charge of arrangements for the Petroleum Jubilee scheduled November 31 and December 1 on the occasion of the annual meeting of the Independent Petroleum Association of America. Commenting upon how hard Buttram was working on plans for the jubilee, the oil editor of the *Daily Oklahoman* wrote:

"Perhaps the reason for this is that Buttram is an independent operator. He has been on top and hit the bottom so hard at times that much of the glamor of the oil industry has been knocked out of his system. He has struggled with the independents and knows their problems; he has dug down and paid bills for his less fortunate brothers until he knows their trials and tribulations.

"In addition to that Buttram loves this big town. Everything dear to his heart is in this community. He has been a part of it since early days when he was a gangling student at Norman. He made his first oil deal in the old Huckins hotel and was so excited he forgot to cash the check for several days.

"Buttram has given so much to Oklahoma City and the oil industry, that everyone in these parts should fall in and take some of this convention work off his shoulders."

1913

Dr. Lucille Blachly, '13B.S., is actively practicing medicine again in Oklahoma City, in addition to her duties as executive secretary of the Oklahoma City Consumers' council.

1914

Speaking at the international convention of the Disciples of Christ October 15 at Kansas City, Mo., John Rogers, '14law, declared that the spread of Communism and Fascism is confronting Christianity with the most serious challenge in its history. A United Press dispatch quoted Mr. Rogers as saying: "Before the onrush of these new movements, other religions seem powerless. The struggle for religious mastery is not between Christianity and other historic religions. It is between Christianity and the new movements, which, if carried to their logical conclusion, will largely destroy civilization." Rogers said Christianity is the "greatest guarantee" against strife. He assailed "pagan philosophers" as inciters of "domestic revolutions" and said "conflicting nationalisms" are the principal causes of war.
