



dent, wrote the following tribute to Halbert which was published in the Norman Transcript: "Bill Halbert came back to Norman this week

he was a home boy and he had made good. "He had adventured in foreign land and great cities but this was the greatest adventure of them all. And he came home so very calmly and quietly—we missed that sparkling spirit—that magnetic handclasp—that smiling, direct look of his. He was so still! But it was the morning of his day of days—his birthday in Heaven. And he had died on his father's birthday. And then I thought of the years that have slipped by since I first knew Bill. He was so gay and happy in those days of his boyhood and his University career. He was always the center of life that flowed around him-never on the outer edge. They all liked Bill because he knew how to be a friend. He early learned the truth that the only way to have a friend is to be one. And he treated them all with a fine democracy. Then he left our Oklahoma University campus and followed his profession across two great continents—North and South America. He endured hardships serenely and philosophically for he was an Engineer; but he never lost his fine sense of humor nor his ability to entirely forget his own discomforts while trying to smooth the path for others. His men loved him, for while he was their party chief he still kept the understanding heart."

Hubert A. Ambrister, '12as, '14law, Oklahoma City attorney, died September 9 in St. Anthony's hospital at Oklahoma City, as a result of an illness.

Mr. Ambrister, who was 45 years old, was a former Sooner football star, and a life member

of the University of Oklahoma Association.

He was a star football player both in Norman High school and the University.

Playing quarterback for three years under Coach Ben O. Owen, he was a member of the first all-victorious Sooner team in 1911.

He served overseas during the World war, and held the rank of first lieutenant in the aviation

While in the University he became a member of Kappa Sigma fraternity.

Since the World war, he had practiced law in Oklahoma City and for a number of years was general attorney for the Magnolia Petroleum company at Oklahoma City.

Survivors include his wife and Pauline, Oklahoma City, his mother, Mrs. S. A. Ambrister, Norman; a sister, Mrs. Maude Wyche, Norman; and five brothers, Sam and Gene Ambrister, both of Norman; Harry Ambrister, Oklahoma City; Roy Ambrister, Pauls Valley, and Clarence Ambrister, Muskogee.

Dr. G. F. Keller, '32bs., '34med, died August 12 in a hospital in Oklahoma City. Death was attributed to blood poisoning.

Lieutenant Jesse Neal, '31eng, was killed August 1 when an army plane he was piloting crashed near Smithton, Illinois. Mr. Neal's home was in Wewoka.

Mrs. Ethel Adair Embry, '24as, died at her home in Oklahoma City July 13. Death was due to heart disease.

#### Runoff winners

Three University graduates besides Josh Lee, senate race winner, received nominations for major state offices in the Democratic runoff primary.

Thurman Hurst, '12law, defeated Edwin R. McNeill in the sixth district supreme court race; Wilburn Cartwright, '20law, won the nomination for third district congressman, and Will Rogers, '30-M.S., won renomination for congressmanat-large. All three of these races were Democratic.

Judge Hurst is now serving his second term as district judge of Tulsa and Pawnee counties. Since January, 1931, when he assumed the position, he has disposed of approximately 5,000 cases in the two counties, including about 475 jury cases.

In addition to his work as district judge during the last two years, he has written 11 opinions for the Supreme Court which were adopted by that court.

His record as district judge was so satisfactory that when he announced for re-election in 1934 not a single candidate from either party filed against him.

Judge Hurst is a member of Phi Delta Phi, honorary legal fraternity, and also the Order of the Coif.

Sooner graduates broke even in state senate races of the runoff election, winning two and losing two.

James M. Wilson, '33law, was runoff winner in District No. 8 (Garfield county), and Joe B. Thompson, '27law, won in District No. 18 (Carter, Love, Murray).

Incumbent Don Wilbanks, '22law, lost to W. N. Barry in District No. 22 (Hughes, Okfuskee), and Sam Sullivan, '37law, was defeated by John A. McDonald in District No. 20 (Atoka, Bryan, Coal).

Tom C. Waldrep, '15law, won the Democratic nomination without a runoff in the Pottawatomie county district.

Alumni who won Democratic nominations for state representatives in the runoff election include: Dale Brown, '37bus, Coal county; Finis C. Gillespie, jr., '35law, Kiowa county; Aubrey M. Kerr, '28law, Pontotoc county; Herbert L. Branan, '35as, Muskogee county; and William O. Coe, '28law, Oklahoma county. Merton Munson, of Lawton,

'31law, received the Democratic nomination for state senator of District No. 17 (Comanche, Cotton, Stephens and Jefferson counties) without opposition.

Munson, now an attorney in Lawton, is serving his second term as state representative and was speaker pro tem of the Fifteenth legislature. He drew no

opponent in either of his legislative races.

O. M. Ginder, '31law, and Loyd W. Hadwiger, '34ex, won the Republican nominations for county attorney and county judge, respectively, in Alfalfa county and will be elected without opposition.
