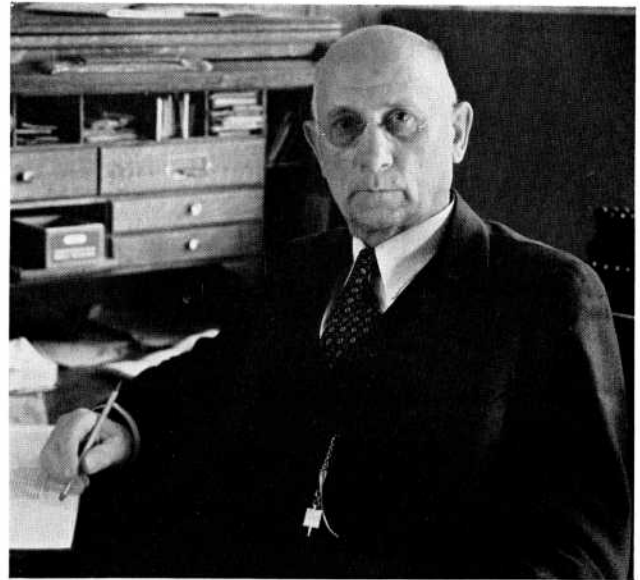

Members of that first 1912 class are all alive today. They include:

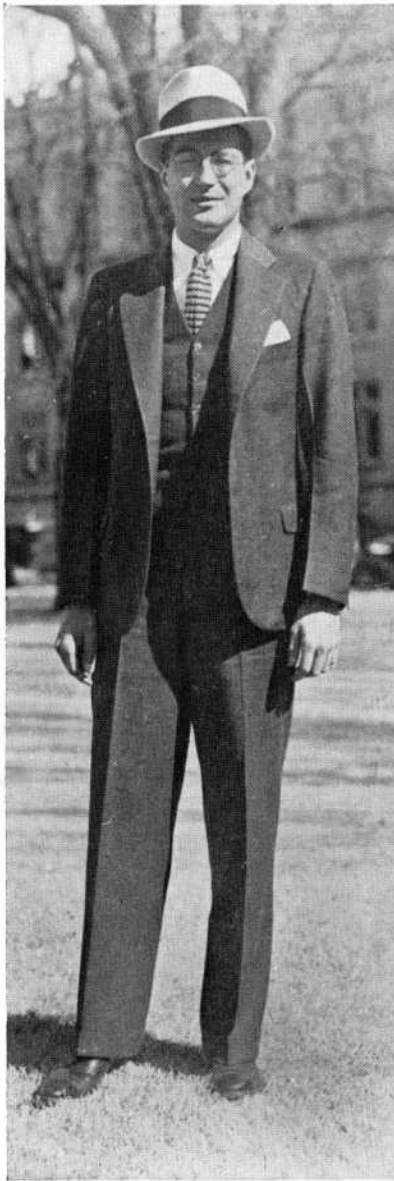
