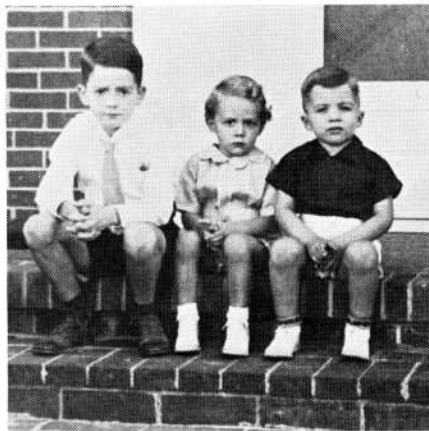
A son was born in October to C. E. Hyde, '16, and Mrs. Hyde, of Fort Worth, Texas.
