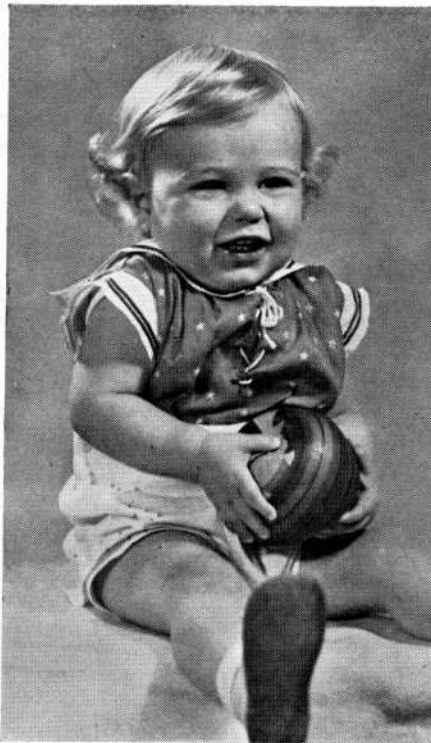

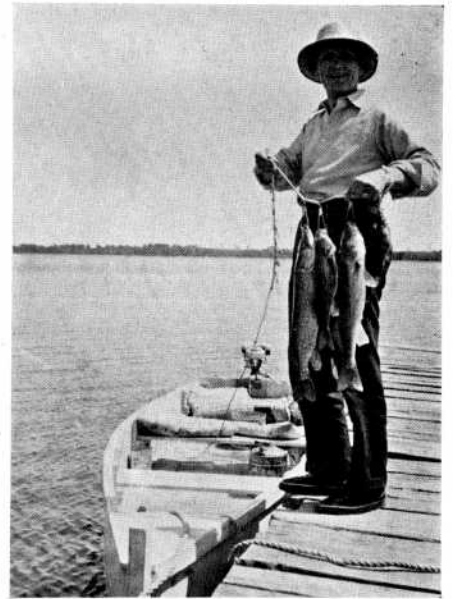

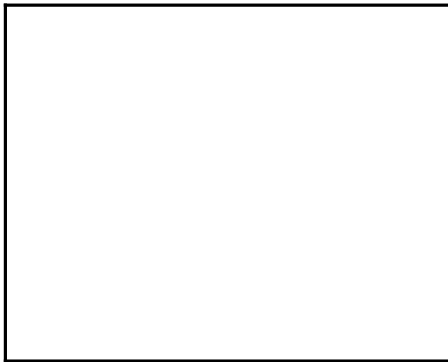

### Attorney's illness fatal

A streptococic infection of the throat cut short the promising career of George E. Massey, Jr., '33law, in late August. He was 25 years old.

Upon graduation from the University, where he was prominent in student activities and a member of Kappa Alpha fraternity, he entered the law office of J. D. Lydick at Oklahoma City. Later he became attorney for the Civil Works Administration.

In July 1934, he became assistant United States district attorney. He resigned this position October 1, 1936, to open a private law practice.

Survivors include his wife, the former Elizabeth Giles, '33, and a 2-year-old daughter, Veta Marie.

### Death takes Marvin Hicks

Marvin B. Hicks, '23ex, of Corpus Christi, Texas, and formerly of Shawnee, Okla., was killed in an automobile accident in July near Cripple Creek, Colo. Mr. Hicks, after attending the University, went to Cumberland University Law School and received a law degree there in 1924. He was associated for more than ten years with the claims and legal department of the Employers Casualty Insurance Company of Dallas, Texas, and at the time of his death was associated with the legal firm of Hubbard, Dyer and Sorrell of Corpus Christi, Texas. Surviving relatives include Rev. Earnest C. Hicks, '22, of Hugo, Okla., and Mrs. A. W. Rogers, (Pearl Hicks, '25cd), of Corsicana, Texas.

### Faculty member's wife dies

Mrs. Thelma Whaley Willibrand, '24fa, Norman, died in late summer of a blood clot following complications of child birth. Mrs. Willibrand, wife of W. A. Willibrand, associate professor of modern languages in the University, was 39 years old. Mrs. Willibrand, who had an M.A. degree from Columbia University, New York, in addition to her degree from O. U., taught art in the public schools of Austin, Texas, and La Grande, Ore. In 1935 she became instructor of art at the University of Oklahoma. She married Mr. Willibrand in May, 1936.

### Accident kills educator

An automobile accident during the summer brought death to Robert E. McCollum, '21, '26 ma, principal of Washington School at Tulsa. Mr. McCollum had been in the Tulsa school system for thirteen years, having served first as principal of Old Sequoyah School. He was active in many worthwhile movements, and was state director for the World Federation of Education Associations. Under the auspices of the National Education Association he was instrumental in the formation of the state committee on international relations and was its first chairman. He was interested in the Junior Red

Cross and a leader in its work. Besides his affiliation with educational organizations Mr. McCollum was a Mason, a Kappa Tau Pi, a Phi Delta Kappa, an Ex-Rotarian, and a Methodist. He was a member of the official board of Boston Avenue Methodist Church, chairman of the Board of Christian Education, and Superintendent of the Junior Department of the Sunday School. Mr. McCollum, who was 46 years old, is survived by his wife and four children.

### Young graduate dies

Mrs. Hazel Bennett Dupy, '36, died in August in a hospital at Port Arthur, Texas, following an illness of six weeks. She and her husband, Thurman J. Dupy, '35 were married in June, 1936, and went to Port Arthur where Mr. Dupy is connected with the Gulf Oil Corporation. Funeral services were held at Texanna, Okla., near Checotah, and burial was made beside her father and mother, Dr. and Mrs. Dyton Bennett. Mrs. Dupy was 23 years. Survivors include a brother, Deighton Bennett, of Texanna, Okla.

### Killed in crash

Robert Rex Reed, '34eng, was killed in an airplane crash at Daytona Beach, Fla., in August. A large passenger plane on which Mr. Reed was a pilot was wrecked when it struck an electric power line that had been erected near the landing field just a few hours before the accident. The other pilot, who was at the controls, and a passenger were also killed. Mr. Reed, 24 years old, was the son of Mr. and Mrs. John H. Reed, Oklahoma City. He obtained his basic flying experience at Kelly and Randolph Fields, San Antonio, and later flew at Langley Field where he won his stripes as lieutenant in the U. S. Army Air Corps. While in school Reed won membership in Tau Beta Pi and Sigma Tau, honorary engineering societies, and was an officer of the student chapter of the American Society of Mechanical Engineers.

### Death takes athlete

Roy Myers, who in 1934 was the star hitter of the Sooner baseball team, died in early September at Liberal, Kan., after a succession of illnesses had ended his baseball career.

Mr. Myers, who was 22 years old, has been ill for more than a year and was on his way to Colorado for his health when he died.

Graduating from the Bristow sandlot team and two and a half years at O. U., Myers joined the Oklahoma City Indians in 1935 as the youngest member of the club and made an outstanding record as a hitter in his first season. Poor health then stopped his active baseball career.

### Medical graduate dies

Dr. L. C. Lane, '29med, died during the summer at an Oklahoma City hospital as a result of a 13-week illness with a sinus infection. He was 32 years old. Dr. Lane was a member of the state and county medical associations, Phi Beta Phi medical fraternity, Junior Chamber of Commerce and the Young Men's Club. He served on the staffs of St. Anthony's Oklahoma City General and Wesley hospitals in Oklahoma City. Survivors include his wife, the former Camille Cassius of Oklahoma City.

### Geology graduate killed

Lieut. Hasting M. Faulkner, '29geol, was killed in July when thrown from a truck in a highway accident in California. He had just taken charge of the Buck Meadows CCC camp near Sonora. Mr. Faulkner, who came to the University from Claremore, Okla., worked with the Gulf Refining Company at Shreveport and along the Gulf Coast in 1929 and 1930. He later went to Cumberland University, Lebanon, Tenn., and received a law degree. During the last two years he was employed in CCC work in California.
