The Trust Fund's First Ten Years

HE TENTH ANNIVERSARY of The Sooner Magazine, celebrated this month, is also the Tenth Anniversary of the Life Member plan.

In 1928, the plan for establishing a permanent trust fund, the interest from which would be available for current expense of Alumni Association activities, was formally approved. However, the work of actually putting the plan into effect required some time, and it was May 18, 1931, when the Executive Board of the Alumni Association adopted the declaration of trust for the "O.U. Life Member-

The declaration papers were prepared by Paul G. Darrough, Oklahoma City attorney, and the board members expressed their appreciation for his careful work. Errett R. Newby, Tom Carey and Neil Johnson were named as trustees of the fund, and they have continued to serve until the present. Looking to the future, the alumni leaders of ten years ago decided that Life Memberships were essential to put the Alumni Association on a more stable financial basis. The cost of a Life Membership, including life subscription to The Sooner Magazine, was set at \$60.00, and it was provided that the entire sum should go into the Trust Fund and only the interest of this fund be available for Association activities.

The theory was that the interest on \$60.00 would be sufficient to pay the cost of sending the magazine to the Life Member. It was provided that if both husband and wife were Sooners, a single Life Membership would make both of them voting members of the Association for life, but that they would be given only one subscription to the magazine.

How has the Life Member plan succeeded? The best answer is the fact that the Trust Fund now amounts to more than \$16,000 and is steadily growing. Undoubtedly it would have grown much faster except for the fact that it was launched at just about the time the depression struck. But the basic soundness of the plan has been demonstrated by the fact that Life Memberships keep coming in steadily.

The total number of Life Memberships received is 237. Nearly 10 per cent of all the members of the Class of 1914 are Life Members. This class ranks at the top in percentage. The class of 1913 is a close second.

The Life Membership Trustees have full power to accept gifts as well as payments for memberships. The original trust declaration stated in part: "It is also expressly understood that said trustees may hold for the benefit of said Association any other funds or properties offered them for the purposes herein named."

On the Life Membership roster, which is appended at the end of this article, may be found a good cross-section of Sooner alumni. The list includes doctors, lawyers, engineers, school men, business men, one of the trustees of the Scripps-Howard newspaper chain, a United States senator, several congressmen, wealthy oil men, housewives, modestly paid teachers, and

Alumni officials point out that Life Memberships are intended for alumni of modest incomes as well as those who are affluent. It was early provided that the \$60 cost of a Life Membership could be spread over a three-year period, payable at the rate of \$5 each quarter. Alumni dues and magazine subscription are then paid for life. A certificate of Life Membership is issued when payment is completed, but the magazine subscription starts when the first payment is made and the alumnus is considered an official member of the Association from the first.

Mr. Hill resigned in 1936 to take a position with the Oklahoma News.

In the first issue Mr. Brandt explained the establishment of the magazine and set the course for its future policies in the fol-

lowing editorial: Thirty-six years have elapsed since the University of Oklahoma was established in the then small village of Norman. During that period, more than six thousand graduates have gone forth, in addition to hundreds of students who were unable to complete their courses for degrees. and ingenious efforts have been made by the alumni association, working without funds and usually under great handicaps, to knit together this great group of former students, but with indifferent success.

Ranking fifth in enrollment among the state universities of America the University was practically the only state school not to have a regular alumni magazine; and one of the few universities
