
National awards to magazine

The Sooner Magazine was one of three alumni magazines west of Ohio that received awards in the annual magazine competition conducted by the American Alumni Council. The awards were presented at the annual meeting of the council held in April at Columbus, Ohio.

The Sooner Magazine received two awards-third place for best portrayal of student life and fourth place for best editorial-and honorable mention in the contest for best general balance.

Only four alumni magazines in the entire United States received more than one award, these being the alumni magazines published at the University of Oklahoma, University of California, Northwestern University and Case School of Applied

Statistics presented at the Alumni Council Meeting revealed that the Sooner Magazine publishes about twice as many pages per year as the average alumni magazine in the nation.



This map shows the distribution of University graduates in the various counties of Oklahoma, as shown in a recent survey made by the alumni office. Approximately 10,000 graduates, not counting former students, now live in Oklahoma
