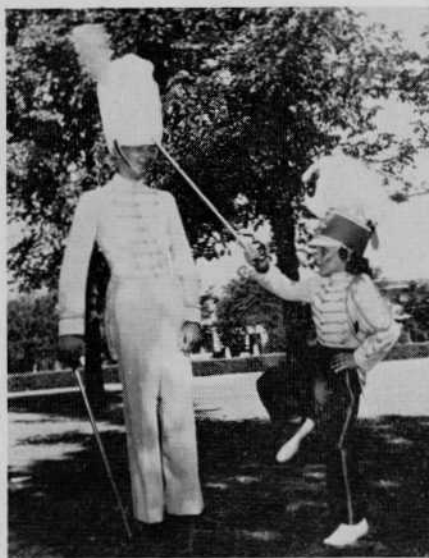
1917
