One of Mr. Memminger's qualifications for president of the Alumni Association is his wide acquaintance with several different generations of students at O. U. He first enrolled on the O. U. campus as a student in the preparatory department in 1919. He took four years of college work and received the B. A. degree. He enrolled again in 1929 and completed most of his law work with the class that graduated in 1931. However, he came back later in the spring term of 1933 and completed his work for the LL. B. degree.

As an undergraduate student in the University, Mr. Memminger took part in class athletics, was interested in student dramatics, literary societies, publications and almost everything else of interest on the campus. He played class baseball, football and basketball. He was assistant business manager of the 1913 Sooner Yearbook and served the next year as member of the publication board. He had a part in a German play presented by Teutonia, German Club, in 1913; the next year he played "Uncle Buck" in the annual burlesque sponsored by the junior class, and he had a part in the senior play of 1914. He found time to serve on the Y. M. C. A. cabinet three years and was treasurer of the organization in his senior year.

However, young Memminger wasn't so completely serious as his record of substantial activities might indicate. It was during his time in school that the engineers' smoke stack was first desecrated by the painting of "D. D. M. C." high on the stack. He wasn't one of the two foolhardy students who volunteered to let themselves be pulled up to the top of the smoke stack on a precarious platform drawn up by a cable, but he was one of the trustworthy men who held onto the cable at the bottom of the smoke stack and enabled the dangerous painting job to be completed without any fatalities.

That's the kind of man Charlie Memminger is. You don't find him doing spectacular things to attract public attention, but you find him always with a steady hand on the cable doing his share of the important ground work behind any worthwhile project in his community or state.
