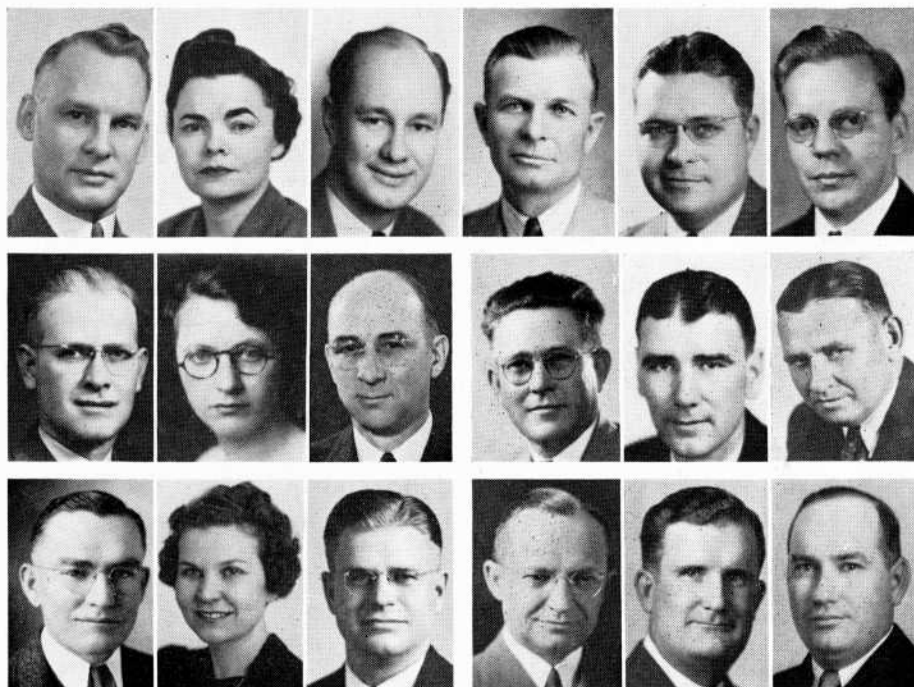

Harrington Wimberly, '24, publisher of the *Altus Times-Democrat*, has requested that his name be withdrawn from the executive board election. However, the ballots had already been printed when the request was received, and it was impossible to remove his name from the ballot.
