### Scholarships

Several members of the class of 1940 received valuable scholarships as the school year ended.

Alfred Naifeh, senior law student, was awarded a \$1,200 fellowship at the University of Michigan, Ann Arbor. He is former president of the Men's Council and a member of numerous honorary societies.

Charles P. Brown, business administration senior from McAlester, was selected to receive a \$1,000 scholarship for study during 1940-41 at the Harvard Graduate School of Business Administration. He was one of 31 persons to receive scholarships out of a group of 365 candidates. Brown was also offered an appointment as an officer in the United States Army as a result of his outstanding R. O. T. C. record.

Charles Suggs of Ardmore and James Emery of Shawnee won \$750 scholarships in a regional contest for college musical comedies sponsored by the American Society of Composers, Authors and Publishers. They received the award for "Serenade to an Heiress" which was produced in May as the annual all-student Sooner Review. The scholarships give them their choice of schools to attend.
