## Print Folio

A folio of a dozen serrigraphic prints has been published by a group of Oklahoma artists that includes many University of Oklahoma alumni. This relatively new graphic medium is well illustrated by a variety of interesting techniques in these prints.

Reproduced in black and white, the serrigraphic prints have the charm of block prints with additional values resulting from the special technique. The prints are presented in a pleasing folio with foreword by Nan Sheets and an introduction explaining the way in which the project developed.
