1901 When Everett Case, formerly of Harvard University, was inaugurated as the ninth president of Colgate University at Hamilton, New York, in September, Milton James Ferguson, '01ba, '06ma, was the official representative of the University. Mr. Ferguson is chief librarian of the public library in Brooklyn, New York.

1911 E. L. DeGolyer, '11ba, Texas oil man and geo-physicist now associated with the Office of Petroleum Co-ordinator in Washington, D. C., branched out into a new field recently when he became a member of Saturday Review Associates, owners of the *Saturday Review of Literature*. This organization, formed July 1 of this year to buy the magazine's stock, includes Henry Seidel Canby, Leonard Bacon and Norman Cousins, *Saturday Review* editor. Last September, Mr. DeGolyer was head of a commission sent to Mexico by the State Department to study oil conservation problems there.

1912 Herschel V. Lewis, '12ba, formerly an Oklahoma City lawyer, has moved to Burbank, California.

1913 Elton B. Hunt, '13law, Tulsa attorney, has been elected Tulsa County Bar Association representative to the Oklahoma Bar Association House of Delegates.

Claude H. Rosenstein, '13law, Tulsa attorney, has been elected president of the Tulsa County Bar Association.

1915 Walter A. Morrow, who attended the University School of Journalism in 1914-15, was appointed September 9 as editor of the Columbus (Ohio) Citizen, a Scripps-Howard newspaper. Mr. Morrow worked on Oklahoma newspapers until 1922, when he joined the Scripps-Howard group with which he was connected mainly until 1938, when he became editor of the Rocky Mountain News in Denver. He is re-entering newspaper work after two years spent in Washington, D. C., as secretary of the National Retailers Advisory Committee, a group organized by merchants to co-operate with war agencies.

1916 W. J. Armstrong, '16law, member of the State Corporation Commission, and T. Murray Robinson, '23bs, Oklahoma City attorney, were recently appointed by Governor Phillips to serve on a four-man committee studying a proposed bill for the repressuring of Oklahoma oil fields.

Featured are a *Cotylophynchus* and a *Dimetrodon*, both U.S.A. natives over 225 million years ago. The remains of the *Cotylophynchus* were discovered near Norman four years ago by J. W. Stovall, professor of paleontology, who directed the painting of the mural.

That night Mr. Yarbrough and the other correspondents snatched minutes of sleep between blasts of machine gun fire, which was getting "louder and closer—and that tin hat felt mighty flimsy." When shells from American guns went over, "they made a beautiful symphony. We

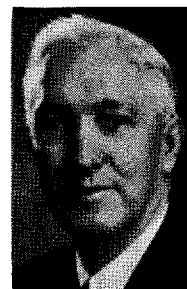

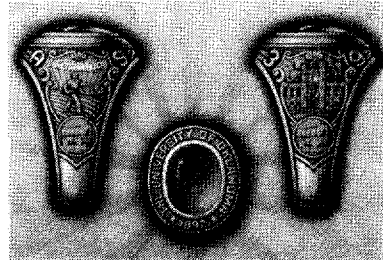
