

Its Class A rating, but it is the only state university medical school in the nation that has had no expansion program for 15 years, Dr. Wann Langston, of Oklahoma Citý, declared in the principal address at the annual Spring meeting of the Medical School Alumni Association, held last month at Tulsa.

Declaring also that the bed capacity of University Hospital is 50 below normal because of lack of funds to operate them, Dr. Langston urged the medical alumni to acquaint the citizens of the state with the needs of the Medical School.

After commenting that many citizens, and some medical school alumni, do not understand the basic purposes and functions of the Medical School, he summarized the functions as follows:

1. Education of young doctors.

2. Care of the sick.

3. Postgraduate study.

4. Aid to doctors who graduated from the institution, and also other doctors practicing in the state.

5. Training nurses.

Dr. Langston emphasized that without proper teaching cases in University Hospital, the instruction program is greatly impaired, and he suggested that cases not suitable for teaching purposes should not be referred to the institution for care. From an educational viewpoint, the present quota system giving each county a quota of patients in the hospital in proportion to its population, is a definite handicap, he said.

The Medical School has co-operated in the war effort by increasing the freshman enrolment from 65 to 75, but has not been able to accelerate the teaching program to less than four years because of lack of funds, Dr. H. A. Shoemaker, assistant dean, reported.

Dr. Shoemaker explained that the salary appropriation for the staff covers only 10 months of the year. There also is a lack of equipment that would be needed for an accelerated program.

Approximately 150 alumni of the Medical School are known to be serving in the armed forces, Dr. Wayne M. Hull, secretary-treasurer of the association, reported.
