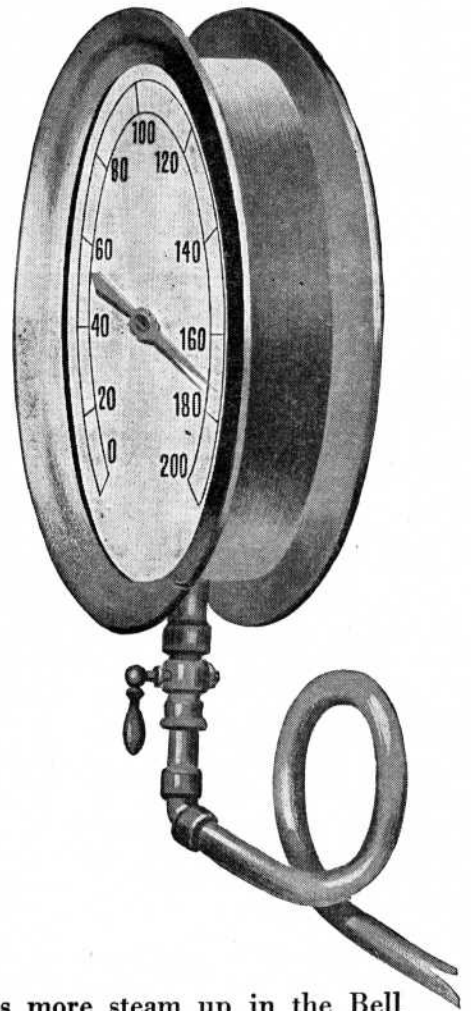

## Head of Association

When the National Apartment Owners Association holds its annual convention June 8-10 in Detroit, Michigan, Albert G. Kulp, '30ba, '34law, of Oklahoma City, will be presiding as president.

The association, although only six years old, is important in the business world as statistics show the apartment industry is fifth largest in capital investment in the United States.

Employing regular counsel in Washington, D.C., the association is particularly interested in presenting the viewpoint of the apartment industry before Congressional committees and federal administrative boards. The association also conducts surveys of operating costs and acts as a disseminating agency for operating and managing problems. It has co-operated with the National Real Estate Taxpayers Association in an effort to assist the development and adoption of uniform state real estate tax laws.

Mr. Kulp went to Washington in January to appear before congressional committees with regard to the rent provisions of the National Price Regulation Bill. As a result of information presented, the bill was modified to prevent freezing of inequities. In original form the bill placed a rental ceiling at the rental schedule in effect in April, 1940. Mr. Kulp pointed out that this would be unfair to communities where a subnormal rental condition had existed during the last two years. As passed, the bill merely authorizes the federal price administrator to establish a price ceiling in the defense areas after local operators have been warned that rents are too high in that area. Even then the rental ceiling is to be a normal rental.

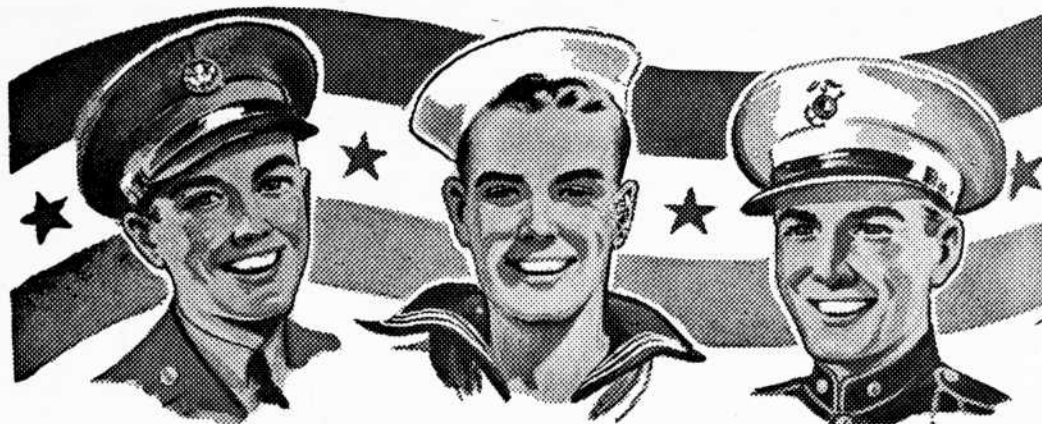

**1936** War conditions are threatening to undermine the nation's educational standards by causing a shortage of qualified teachers. C.
