## Activated by Army

The University School of Medicine last month was activated under the Army's war training program and about one-half of the students enrolled went on active duty in private's uniforms.

Of the 240 medical students, 115 resigned from their reserve second lieutenant's commissions and applied for active status. It is expected that by mid-winter nearly all the students will be either in Navy or Army uniforms.

The government pays the bills for the men in uniform, each soldier-student to receive tuition, subsistence and regular private's pay, \$50 a month.

Students will be assigned to the Medical School by the Army, but as a whole, the educational program will not be altered greatly, school officials said. President Brandt said the Medical School program will be a part of the University's Army training contract. The students will probably be college men recently inducted into the armed forces from pre-medical courses.
