

"However, we promise to get them in good standing immediately, and hope to secure several life memberships for the Association out of our ranks.

"We plan to be very active. Besides taking on special projects to benefit the University, we are going to have a good time. Major Stacy heads up our entertainment

Oklahoma City Club

Charter for the University of Oklahoma Alumni Club of Oklahoma City was formally presented at a dinner meeting of one hundred alumni and guests January 26 in the Biltmore Hotel at Oklahoma City.

The presentation was made by T. R. Benedum, '28law, of Norman, president of the Alumni Association, to Kermit J. Hardwick, '29bus, president of the Oklahoma City Club. Organized many years ago as an unofficial club to sponsor a Homecoming dinner-dance each fall, the Oklahoma City group voted at a luncheon meeting in early January to petition for a charter and become an official charter club under the plan adopted by the Association's Executive Board last year.

Dr. George L. Cross, who became acting president of the University January 1, made his first public appearance before an alumni group at the dinner meeting in Oklahoma City. He described the University's war training program, discussed the problems of the University College plan, and predicted a great future for the University after the war. He warned that the University is badly in need of increased financial support for increased facilities and for a better faculty salary scale.

The dinner program included songs from the musical show *Oklahomal* sung by Wilda Griffin, '27fa, '33fa, assistant professor of music at the University; and the showing of moving pictures of the Sooner-Missouri championship football game with commentary by Dale Arbuckle, '27law, '36ed, director of athletics. Stewart Harral, '36ma, director of press relations for the University, was toastmaster.


Dr. Cross's address at the dinner resulted in the following editorial published in the Oklahoma City Times two days later:

Doctor Cross, acting president of the state university, speaking before the state alumni association, mentioned the same needs of the institution that have been emphasized over and over again for many years.

Those needs are more buildings, more equipment, more facilities and higher pay for instructors, all of which means more money.

It is well to keep hammering at this subject. Something may be done about it eventually. Improvements and additions to the university's physical plant have not kept pace with the growth in student enrolment or the school's growing service program. The university is crying for wings of expansion. It continues to exist on clipped rations. In the professorships, the scale of pay at O. U. is as much as \$500 a year lower in each rank than in many other institutions in the midwest and southwest area.

The state administration and the legislature always have seemed to manage to provide, somehow, for other forms of state service that require money and a continued flow of backing, while higher educational institutions are left on the shelf and forced to remain in the begging line. A two percent sales tax is earmarked for a definite service, an extra high

tax is collected on cigars and cigarets for certain purposes, our state has one of the highest income tax rates in the land, most states have a lower gasoline tax than we do.

If the leading educators will continue to remind the people and the authorities that Oklahoma ranks low in the matter of providing for higher education, some day there may be a rearranging of the general spending and enough funds earmarked specifically for the purpose of making our university rank with the best of them, even at the pay window.
