

I am inclosing a letter I received from a graduate in geology who has been working with the United States Geological Survey, Alaskan Branch. His letter contains so much of interest, I thought possibly you might like to use part of it or all of it in the Alumni Magazine,

Dear "Doc" et al:

Safari

.... After two busy days getting my permission to enter Alaska and naval flight priority, I flew to Fairbanks via P.A.A.... Four days in Fairbanks getting things ready. Quite a town with about half the houses the old log cabins of the gold-rush days of 1900. Pretty busy one too.

We left on June 8 for an extended trip into the hintherland southwest of there. Had a 25-foot boat with outboard, 22 and a half horsepower, and a native for boatman, guide, etc.... First stop, five days later, was--Mountains.... Saw lots of moose and other game and had to bypass within 125-150 feet of a large brown Kodiak bear and her two yearling cubs. She wouldn't give an inch. Our guide had a 30-30 but we are glad we didn't have to see how good he was with it.

After ten days there headed for another place 210 miles from--where there were couple of cinnabar claims to look over. This trip entailed three days of extremely fast and white water and we sure were fortunate in having a good man on the motor. Last day we cached our motor and gas and pulled, pushed, etc., the boat up a small creek through beaver country. In places the boat was too long for the curves or too wide. We made it, though, with no back packing.

From this camp went into the hills a few miles to a tent-cabin left by a bunch who tested the area. Spent three weeks on one claim and a week on the other. Found a lot more work than we had figured on and so got very low on grub-beans and baking powder biscuits for most of a week. There was a young prospector in there, owner of the claims, and he fed us the last week over at his place, five miles from the first claim.

Four days after we arrived, we got back to camp in the evening and found a note from our guide, "I go to-So there we werealone. He did the same thing a year ago to the prospector. We figured he probably walked to his winter place-40 miles-and got a boat there since he had taken only his mosquito netting. Ten days later, when we went back to cache for more food, we found he had taken the boat, which we rented from his father. Well, we were in a fix but could do nothing about it so worked on..

Arrived back here about two weeks later than we had been expected and they were all sure glad to see us.
