

#### O. U. Farm Administrator

Of recent years so many University of Oklahoma graduates have ascended to high places in industry, education and the military that it is no longer news when another does so. But it is a noteworthy event when a Sooner alumnus attains eminence in the field of agriculture.

This happened recently when Joe C. Hayes, '31 bus, was named director in Oklahoma of the Farm Security Administration, an agency of the U. S. Department of Agriculture responsible for helping some 100,000 families on small farms and ranches in the state to get back on their feet and become moderately prosperous members of the community. His organization also shares the responsibility for helping World War II veterans to get started on the farm or to buy a farm or ranch of their choice.

Mr. Hayes brings into his new position ten years of successful experience in extending financial and educational assistance to small farmers and ranchers. At the age of 37, he is one of the state's youngest administrators of federal and state governmental agencies.

Ability to handle difficult administrative assignments has been an outstanding characteristic of Mr. Hayes' work with F.S.A. and the courses in economics, finance and sociology in Dean Adams' Business School must certainly have contributed to this skill. This probably accounts for his ability to progress in a field usually dominated by those technically trained in agriculture.

He has had noteworthy experience, however, of a non-scholastic nature in dealing with farm people that has given a keen insight in the usually solid, patient, logical mental processes of those who make their living from the soil.

For many years his father was engaged in the mercantile business with a rather large general store in McLoud. As a youngster, Joe Hayes grew up almost among the stacks of flour and feed, shelves of grocerics, hardware staple items and candy counter of this store. The senior Mr. Hayes did an extensive credit business and his son gathered some ideas that were to serve him well later in his profession. As a youth, Joe also worked at the cotton gin maintained as an adjunct of his father's store, weighing and buying the cotton. McLoud at one time was quite an inland cotton market and the youngster assisted his father in buying by "climbing wagons," cutting samples, and opening the conversation.

The new F.S.A. state director isn't the only member of his family to hold an Oklahoma University degree. In fact, at one time he, two brothers and one sister were all in school. The two elder brothers, Charles H. Hayes, '26bus, and Russell R., '30e.eng, are now associated with the Oklahoma Gas and Electric Company in Shawnee and Harrah respectively. The sister, Mrs. Evelyn Williams, who received her degree in library science in 1931, is now a housewife in Tulsa. Mrs. Williams attained the distinction of being elected to Phi Beta Kappa in her junior year.

As a student, Joe Hayes was among the better of those who lived at the Masonic Dormitory. He was elected to Alpha Kappa Psi, honorary business fraternity, and several times made the honor roll.

As many readers will remember, the years of 1928 and 1929 were none too prosperous for many farmers, country merchants and others depending upon farmers for their income. It became necessary for one of the Hayes brothers to leave O. U. temporarily and help with the schooling expenses. Younger and not so near graduation, Joe felt that he could better stay out a year or so than any of the others, so he spent these two years helping to build up the family "college fund." He worked at hard physical labor for a meat packer and as an apprentice carpenter. He returned and received his degree in 1931.

When Joe C. Hayes took his first job with the Resettlement Administration, predecessor of F.S.A., as administrator for Latimer County, he was working with a people with whom he was familiar, and his ability to inspire and lead debt-depressed, depression-ridden farmers made up for his lack of technical training in agriculture.

At one time in the history of this part of Oklahoma, coal mining had been the chief support of several communities. Later, a number of factors contributed to the closing of most of the mines, and a considerable number of miners moved onto small acreages to make their living on the land.

Lacking a rural background and with insufficient resources, many of them were fighting an unequal battle with the forces making for rural poverty. Joe Hayes came in with food grants for the destitute and with sorely-needed financial assistance for those who could pay it back. He studied better farming methods and encouraged his borrowers to put them into practice.

This very day, a number of modestly prosperous Latimer County small farmers, who produced much-needed food and fiber during the war and sent many sons into the armed forces, attribute their start to the young, boyish-looking small-town boy who came to them in their time of need.

Sound judgment and ability to handle difficult administrative assignments accounts in a large measure for Mr. Hayes' rapid advance with F.S.A. From Wilburton he was transferred to Coal County, where once again the problems were similar. He later went to Muskogee County, which had at that time the largest number of farmers in the state needing loans and instruction in good farming practices.

He was made district supervisor for F.S.A. over nine counties in western Oklahoma in 1939 and since that time has held positions at the state office in Oklahoma City and the regional office in Dallas, Texas.

The new state F.S.A. director is married to the former Miss Eula Mae Brock, Durant, an alumna of Southeastern Teachers College, and they have a daughter, Elizabeth Ann, age 7. His offices are in the Federal Building in Oklahoma City.

#### **Outstanding Faculty Woman**

Miss Lucy Tandy, '30ba, '32ma, director of the University's correspondence study department, has been named as the outstanding faculty woman for the year by Theta Sigma Phi, honorary journalism fraternity for women. The award was made at the organization's annual Matrix Table banquet held on April 17.

Miss Tandy has done outstanding work in the promotion of the study of Spanish in Oklahoma and has done a noteworthy job in developing the University's correspondence study service into one of the finest in the nation. After having received her A.B. and M.A. degrees at the University, Miss Tandy had studied in Madrid, Spain, and at the University of Mexico.

She is a member of Phi Beta Kappa, Kappa Gamma Epsilon, Business and Professional Women's Club, American Association of University women and the American Association of Teachers of Spanish. She has served as president of the four latter organizations.

# O. U. Goes International

In spite of wartime traveling restrictions prevalent for several years, the University of Oklahoma had 40 students registered in school this last semester who were from outside the continental United States. These came from Canada, Mexico, Central America, South America, Hawaii and the West Indies.

The cosmopolitan influence of these students is felt on the campus the year round, but it is most noticeable when the colorful Pan America Week celebration is in full swing. Latin American speakers, exhibits and folk plays highlight the week, which is climaxed by a big fiesta. During the fiesta the spotlight is flashed on hot Mexican food, gay Spanish and South American dances and lilting Latin American music.

The idea for such a celebration originated at the University nearly ten years ago and has been copied since by numerous other colleges throughout the United States, as well as having received the endorsement of the Pan American Union in Washington, D. C. Pan America Week is sponsored annually by the Las Dos Americas and the Los Centro Latinos Americanos clubs under the direction of Mrs. Stephen A. Scatori, wife of one of the modern language professors at the University.

The College of Engineering attracted the greatest number of students from afar with an enrollment of 21. Next came the University College with 12, of which 9 were pre-engineering, 2 general and 1 pre-business. The College of Arts and Sciences claimed the remaining seven, five of which were enrolled in the School of Geology.

# Farmers Lead List in Check Of O. U. Parents

Farmers send more sons and daughters to the University of Oklahoma than any other occupational group, it is shown in a recent survey of parents of the 5,500 students.

Three hundred and fifty-nine students listed farming as their parents occupation to top all groups. Two hundred and seventy-seven parents are engaged in some phase of the oil business. In third place are 124 lawyers whose children are attending the University.

The butcher and the baker but not the candlestick-maker are represented in the list which covers practically every trade and profession. For instance, there are 120 merchants and 117 salesmen. Fiftyseven parents are accountants, while 73 are carpenters. Twenty-five ministers have sent their sons and daughters to O. U. Seventy-four physicians are on the list.

Forty-eight teachers, 22 professors and 19 superintendents and principals are listed from the education profession. Forty-five parents are engaged in the automobile business, while 37 are in banking. Parents of 83 students are employed by railroads. Fifty-nine are engineers of various types.

Some of the occupations in which only one was listed included stonecutter, florist, plasterer, confectioner, junk dealer, customs official, jailer, horse trainer, entomologist, playwright, and timekeeper.

Hawaii has contributed one Sooner student-Jane E. Steen, Honolulu.

#### Crowds, Crowds, Crowds!

The old woman who lived in the shoe may have experienced a housing shortage, but she had nothing on the Student Memorial Union at the University of Oklahoma where students are jamming in the doors, crowding in the rooms and spilling out the windows.

Elaborate planning to take care of the greatly increased enrollment this year overlooked the student's favorite hangout. The result was that weary students who sweated out the 101 lines at enrollment are now finding all college life one continuous series of lines. They stand in line to eat or buy a coke. They stand in line to buy books or use a bridge table. They even stand in line *outside* to get *inside* those Union doors.

Over 4,000 students, alumni and faculty members visit the Union daily, often more than once. At least 2,000 of that number eat their meals there. One line in the cafeteria exists to accommodate them and 60 tables to seat them. Lunch hour has become an hour and a half, making a problem for the student with a one o'clock. Those who just drop in during the afternoon consume 2,500 cups of coffee, 3,000 cokes and 500 ice cream cones every 24 hours. The fountain adjoining the cafeteria serves four students at a time.

The familiar phrase "meet me in the Union" is fast going out of existence. For when Joe meets Betty in the Union cafeteria today he has to tackle a traffic jam at the door, usually a ten minute effort. A 15 minute search for a table results in sharing it with 8 others a table meant to accommodate 4. This is the situation during each class break and mid-afternoon period.

The story doesn't end in the cafeteria or the daytime. The well known U.A.B. Friday night dances in the Union ballroom tell the same tale, inadequate seating capacities, a traffic jam and more lines. The crowded dance floor has reduced dancing to a series of bumps and apologetic "I beg your pardons." Couples wishing to sit this one out are forced to perch in the windows, if there is one vacant, or stand along the walls. This involves more collisions between dancers and onlookers.

The cafeteria has been opened for service during intermissions. By the time all the students are served and have finished their cokes the dance, too, is finished.

The Union game room plays host to well over 1,000 students daily. The bridge tables, four snooker tables, four pool tables and one billiards table are at their disposal. That puts at least 100 students in the kibitzer class during the peak hours and involves, of course, standing in line for tables. An adequate provision of chess, checker and other gameroom equipment lies idle for want of space in which to use them.

The weary student, still seeking a little relaxation, sooner or later makes his way to the Union lounge. Here he finds around 50 comfortable chairs and sofas—all filled. The peace and quiet of the lounge is marred only by students wandering back and forth looking for an empty chair. The patient ones stand in line.

The Student Memorial Union was built to honor Sooner alumni and students who fought in the first World War. Today its facilities are open to over 5,300 students, at least one third of whom are veterans. Many more are expected. The Union has an unexpected opportunity to serve the veterans of the second World War. Everyone wants to "meet you in the Union" if there were only enough room.

# All-University Sing

Everyone got into the sing of things at the University of Oklahoma in early April. The purpose of this vocal tuning up was the first annual all-University sing presented April 6 in the college amphitheater by the Union Activities Board.

A crowd estimated at over 1,200 saw the Delta Delta Delta sorority, Phi Gamma Delta fraternity, Logan Hall independent women and N.R.O.T.C. choruses walk off with top honors in their respective groups over a field of 21 competing choruses. The idea for the sing was taken from a similar

program at Purdue University. This all-student

program, the first of its kind in the Southwest, will become an annual event on the O. U. campus.

Judges for the event were Mrs. Jessie Clarkson Gilkey, '27bfa, Oklahoma College for Women music faculty and former University faculty member, James Neilson, Oklahoma City University, and Chester Francis, director of the Classen High School choir in Oklahoma City.

Each chorus sang three numbers, one of which was the O. U. Chant written by Mrs. Gilkey. Choice of the other two songs was left to the chorus directors and everything from popular selections to semi-classics was presented.


# **Regular Faculty to Teach**

The Board of Regents named the Oklahoma City architectural firm of Hudgins, Thompson, Ball and Associates to plan the music practice building. The \$100,000 bond issue for the building which was previously approved will be retired with practice fees.

A special meeting of the board was held April 24 to receive bids on the 96 unit project for married veterans. \$275,000 worth of bonds have already been sold to finance the project. The apartment buildings will be two-stories and have north and south ventilation. Each of the four buildings will have laundry and storage space for each renter. Sorey, Hill and Sorey, Oklahoma City, are architects for the project.

The Board voted to issue \$200,000 worth of bonds to purchase and remodel the Oklahoma Hotel (former Masonic dormitory for men) now owned by the Midcontinent Life Insurance Company. \$125,000 of the bond issue will be used to purchase the structure and \$75,000 of the amount will be used for remodeling.

The new policy on admissions recently approved by the Board and which will go into effect beginning with the fall semester of 1946 reads as follows:

1. Non-resident freshmen will not be admitted. They should be told to complete their first year's work in the college of their own state and it should be pointed out that the specialized training which they seek at the University of Oklahoma is built upon general education which can be taken at most colleges.

2. Non-resident sophomores will not be admitted to the University next fall unless there is a peculiar reason why the specialization involved in the particular program necessitates the student's taking more than one-half of his sophomore work in the field of specialization, and then only if his field of specialization is not offered in the schools of his own state. Good grade records will be required of all students admitted. Efforts should be made to limit the non-resident sophomores to not more than 500 and preference should be given to veterans over non-veterans.

3. Non-resident juniors will be admitted if they are veterans with good records and come from states bordering Oklahoma. Outstanding students from foreign countries and from non-bordering states will be admitted to pursue special programs where it is deemed to be to the advantage of the University to have such students enrolled. Not more than 500 such juniors will be admitted.

4. Non-resident seniors may be admitted if they are veterans with good records from bordering states. Outstanding students from foreign countries and from non-bordering states will be admitted to pursue special programs where it is deemed to be to the advantage of the University to have such students enrolled. Not more than 550 should be admitted.

5. No limit will be placed upon resident students, veteran or non-veteran, men or women, except that of scholarship.

6. Students now enrolled in the university and and former students who have been in the service will be allowed to re-enrol next fall if their records at the University are such that, if continued, they will meet maximum requirements for graduation.

In their May meeting, the Board of Regents voted to have, beginning this fall, a general athletic fee for all University students. The \$10 fee would cover 39 events, including football, basketball, baseball, track, swimming, golf and tennis. Admission to single football games will be \$3, it was pointed out, while affairs included on the ticket would average around 20 cents apiece. A large percentage of all Big Six Conference members have already adopted this general fee plan. The recommendation for the fee will have to be approved by the higher regents.

The non-instructional budget for the next fiscal school year and the summer school budget were approved.

Twelve music scholarships for outstanding high school music students were approved by the Board. The scholarships, which will cover all music course fees of the winners, will be awarded under a plan worked out by President Cross and Dean Salter.

The Board authorized President Cross to work out details on the sale of the \$1,300,000 bond issue for 500 pre-fabricated houses with the R. J. Edwards Company, Incorporated, Oklahoma City. He was also authorized to sign the contract after details are worked out. There will be 200 houses with two bedrooms and 300 with one bedroom, all completely equipped. Delivery is due to start within two weeks and all the houses are expected to be ready for occupancy by September 1. The General Housing Corporation of Dallas has contracted to supply the University with the 500 houses.

# Dr. Gittinger Resigns Post

Dean Roy Gittinger, '02ba, known by thousands of University of Oklahoma students during the past 44 years, will lay aside his administrative duties this summer to devote full time to teaching.

The 68-year-old University veteran recently, asked the Board of Regents to resign as dean of admission July 1. He will be succeeded by Dr. J. E. Fellows, registrar and director of admissions at the University of Tulsa.

Dean Gittinger joined the University faculty in 1902, a few months after receiving his B. A. degree. In addition to teaching English history, he successively held administrative positions of principal of the preparatory school, registrar, dean of undergraduates, acting dean of the Graduate School, dean of administration, and dean of admission.

A native of Iowa, Dr. Gittinger came to Oklahoma in 1900 to complete his undergraduate work. He went to summer sessions at the University of Chicago and obtained his M. A. degree in 1906 and later earned his Ph. D. degree at the University of Chicago in 1916.

In his 44 years on the campus, Dr. Gittinger has spent only one winter term on leave. In point of service he is the senior professor on the faculty and has held a full professorship since 1905.

In 1945 he was one of four Oklahomans chosen for the Oklahoma Hall of Fame. He is the author of two books-histories of Oklahoma and the University—a Phi Beta Kappa and member of vari-ous educational and historical societies.

# Housing Improves For Both Single, Married Students

Veterans' housing at the University assumed a brighter luster this week with the purchase of 500 prefabricated one and two-bedroom houses to be ready for occupancy by September.

The figure does not include privately owned apartment houses, expected acquisition of additional barracks for conversion to 555 units and living quarters of Norman residents and commuters.
