"My Dear Mr. Beard:

"My husband, Bob Garrett, '12ba, died on March 4th of this year. He was stricken with a fatal heart attack, while on a field trip down near Bristow. His car had been stuck in the sand and a farmer came to his assistance. After Bob got the car on solid ground, he said "It is only a little ways down to the farm house where I'm going, and I believe I will just walk." They said he walked about a hundred yards and then fell to the ground, death being instantaneous. He was buried here in Tulsa on March 7th in Rose Hill Mausoleum. He had just reached his 59th birthday on February 15th and was trying to get all the loose ends cleared up so he could retire next year to a more leisurely life.

"Of course it was a terrific shock to me, even though he had been seriously ill in 1941 from a heart attack at the office and took almost a year out from his business. As he got to feeling better he gradually gained momentum again and anyone active in the oil business has to have so many irons in the fire.

"I have traveled with him so much since our marriage in 1920 (June 15th—Jerry Newby was our best man). Especially in the past four years when he has not been so well. However, I just had not gone on that particular day and I am still grieved about that.

"How grateful I am though for the years of companionship I have enjoyed with Bob. I can truly say he has been the greatest inspiration in my life. His thoughtfulness, especially about little things, was amazing. He was a man whom both women and men admired and liked sincerely. He was proud of his alma mater, O. U., and very loyal to its memory. If things ever work out so I can, I

hope to have some kind of a memorial for him down there—something that will be alive and keep on helping someone to help themselves, which was his idea of doing good. He is missed by many, who have told me of kindness and good deeds all along the pathway of his life, and I feel very proud that I had the privilege of being his wife. The void in my life can never be filled. I can only hope to try to carry on where he had to stop. I am at present acting as executrix of his estate and am keeping the office.

Although Mr. and Mrs. Tate have been married for almost four years, an error in Veterans Administration files placed him on the single veterans pay scale. During this \$65 a month period the Tates spent most of their savings.

The next meeting was in March, 1946, at the University of Oklahoma. A wedding followed May 8, 1946. Making Norman their home, both attended the 1946-47 school year at the University.

The Milnes, Mr. Tate, Mr. Folmar and Mrs. McDonald, are only a few of the Sooner City dwellers who have found it necessary to cash terminal leave bonds to stay in school. While many are desperately holding on to their bonds, hoping to be able to keep them until maturity, a large number have indicated that they may be forced to cash theirs also.
