## Dallas Decision!

The University's decision to complete the contract calling for three more Oklahoma-Texas football games at Dallas and then switch to a home-and-home arrangement was approved in special meeting November 29 by the University Alumni Association Board, the University Athletic Council, and officers of the O. U. Dad's Association, at a joint meeting on the campus.

Action was taken following a report by Dr. George L. Cross, president, explaining that the University could not honorably withdraw from the Dallas arrangement without violating its contract with the University of Texas as well as with the Cotton Bowl association.

The president said such a withdrawal could cost the University about \$21,000, of which \$5,000 would be a forfeit to Texas and the balance a refund of concessions in division of game receipts which the Cotton Bowl association has made to the two schools in the past few years.

The Alumni Board also voted to rescind its action taken at the Homecoming day meeting when it recommended that if more games are played at Dallas the O. U. band not be sent to the game and no game tickets be sold in Norman.

Dr. Cross told those present that the series will be completed only if amicable relations continue each year, and should objectionable events occur in any Dallas game, the series would then be discontinued.

This discontinuance clause would also apply to the home-and-home arrangement, so the future of Oklahoma-Texas football relations depends on keeping the game activities on a friendly basis with no disturbances.

Dr. Cross said the two schools will each sell half of the tickets for the three remaining Dallas games, and that the schools will have the assurance of Dallas leaders that Oklahoma people will be treated fairly by the hotels on room accommodations.

## Alumni 'Life' Fee Goes Up; Fund-Raising Plan Okayed

At the annual Homecoming meeting of the Executive Board of the University of Oklahoma Association held November 1 and at the special meeting of the Board on Saturday, November 29, definite action was taken on several items of business pertaining to the Association's future work. Among the items acted upon by the Executive Board were:

1. The University Alumni Association Board decided to set up a fund-raising committee which will co-operate with the University of Oklahoma Foundation in promoting gifts to the school.

The committee will be composed of four alumni members, four members appointed by the president of the University, and the executive secretary of the foundation, after such a secretary is chosen.

Action was taken after Roscoe Cate, financial vice president of the University, and acting secretary of the foundation, explained the present status of that movement.

The Foundation trustees and the University Board of Regents are now in the process of selecting an Executive Secretary, who will be in charge of all fund-raising activities.

2. Other action taken by the Board, according to Ted Beard, secretary, was the recommendation that a constitutional amendment be adopted increasing the life membership fee of the Association from \$60 to \$80. A committee of which Tom F. Carey, Oklahoma City, was chairman, recommended the change because the income from the \$60 fee has declined so much in recent years it does not pay the cost of servicing life memberships.

3. Another recommendation of the committee, that annual fees be raised from \$3 to \$5, was rejected by the Board.

Following the close of the meeting of the Executive Board, the traditional Aggie-Sooner luncheon was held in the Blue Room of the Oklahoma Memorial Union. For 29 years it has been an annual custom that the host alumni at the annual O. U.-A. & M. football game, serve alums from the visiting school before the traditional football battle.

Ten officers and board members of the Oklahoma A. & M. Alumni Association met with the O. U. board as hosts this season.
