Editing a Daily may be rough, but getting out a weekly in Nagoya, Japan, is like "beating your head against the wall." That's the report of Robert Peterson, '44-'45.

Peterson is now in Nagoya where his sole duty is the publishing of a weekly, four-page tabloid newspaper for the air force. Getting material is "comparatively easy," according to his report. "It's getting it printed that drives us mad."

The apparent reason for this difficulty has been traced to the big Jap newspapers who do the printing. "We work," Peterson wrote, "through the foreign affairs section, principally because they jokingly say they can understand English.

"All type is set by hand by shop men who can't read, write or understand English. They look at a letter on the copy, then look all over their case to find one like it. If they find something similar first, they put it in. Consequently, the first proof looks worse than a proof-reading problem for journalism 101."

Peterson added that reproduction was also a problem. "Up to last week," he said, "pictures were very bad—a mass of grey in some cases. Last week they were clear and sharp—and the paper was a mass of oil. Four days later, they still are not dry."

Editorial offices for the air force tabloid are located in a modern office building for the convenience of those "going mad."
