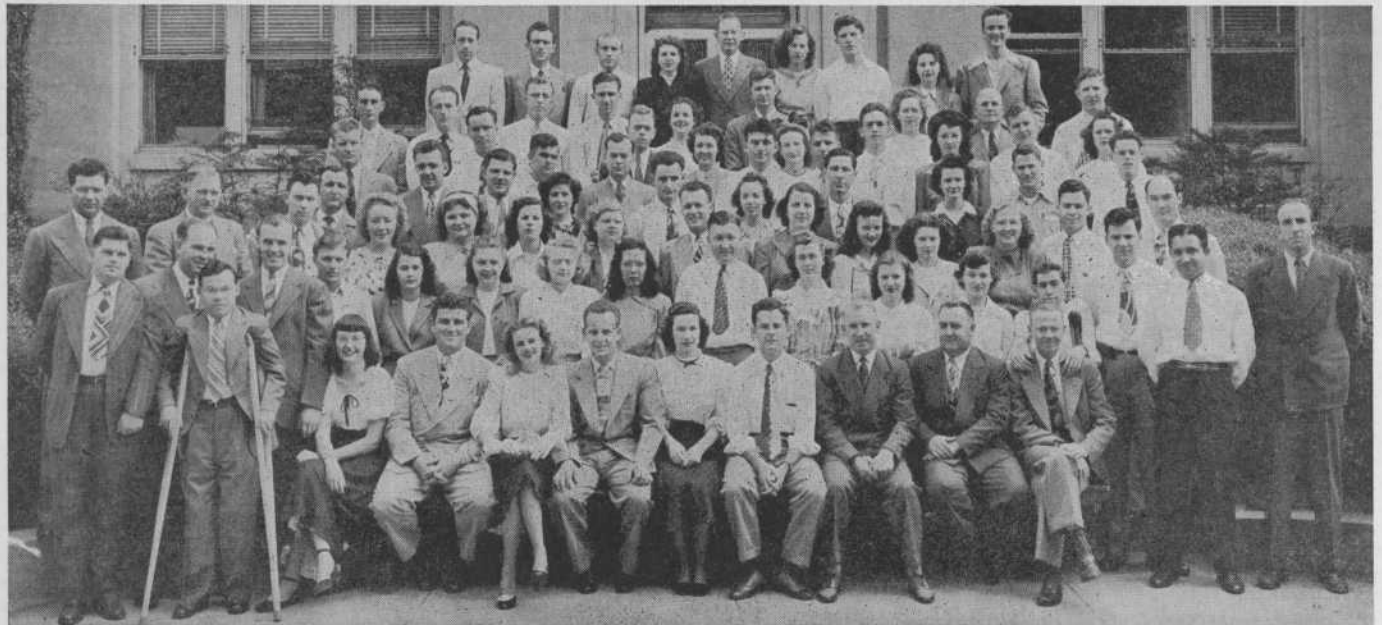

## Hospital Grant Approved

The University Hospital in May was assured of 120 much-needed beds when the U. S. Public Health Service approved a \$37,087 federal aid grant. The grant was made to help equip the new hospital wing completed earlier this year.

Representative Mike Monroney said the federal money amounts to one-third of the \$105,261 budgeted to equip the new addition.

The grant was issued just one month after Dr. Mark Everett, dean of the University of Oklahoma Medical School and superintendent of University Hospital, appealed for federal help.

## Nurses' Home Is Dedicated

Dedicatory services for the new University Hospital nurses' home were held in early May. Denver N. Davidson, justice of the Oklahoma Supreme Court and representative of Governor Turner, delivered the address.

Approximately 500 persons assembled in the park in front of the building to hear Davidson speak of the building as one "with a noble purpose," the dedication as one "to humanity."

The home was accepted for the University by Dr. Cross; for the School of Medicine by Mark R. Everett, dean, and for the School of Nursing by Mary R. Caron, director. The dedication coincided with graduation week for a class of 12 nurses.

The building, which is modernistically designed and decorated, cost an estimated \$475,000. It houses 88 nursing students, and is complete with a lounge, auditorium and classrooms. The plan is to increase the capacity of the nurses' training quarters for 300 student nurses.

Residence rooms contain paneled desks and closet space, two beds and the latest in auxiliary furnishings.
