A connecting tunnel is planned underneath 13th street, extending from the proposed Medical Research Institute to the main hospital.

Following four years of intensive medical training, graduates must intern for one year at an approved hospital. Then they are on their own. Under the new Sooner medical setup, they will be ready.

BOOKS

A Struggle for Survival

WARPATH AND COUNCIL FIRE, by Stanley Vestal, University of Oklahoma professor. Random House, \$3.50.

Stanley Vestal's 20th book, *Warpath and Council Fire*, is the culmination of 50 years study of the Plains Indians' struggle for survival during the encroachment of white men. Mr. Vestal received most of his information from participants or witnesses in the battles, campaigns and councils carried on during the years 1851 to 1891.

The 40 years of warfare started in 1851 with a great Peace Conference. The government wanted to make the Indian country safe for white men passing through, so a conference was called, attended by thousands of warriors and their families. The points of the treaty were, that the Indian tribes should not fight each other; that the white men be allowed to build forts and roads in Sioux country; and, that they elect one chief of the Sioux nation. The Indian tribes continued to fight one another, the white men had a hard time building roads and forts and the chief appointed was killed shortly after he was appointed, as he knew he would be.

The agents sent by the government to give out rations for the friendly Indians were, for the most part, corrupt and greedy. They sold the rations and retained the money for themselves and let the Indians starve. The "Indians' commissary," the buffalo herds, had been sharply diminished by white men, who shot them for sport.

The inefficiency and stupidity of the American agents sent to "educate" the Indians to the white man's way of living is amazing. They made no effort to understand the traditions, religions, and

pride of the "bloodthirsty Indians." They wanted the warriors to give up their weapons, settle down on the reservations and farm. The treatment the Indians received on the reservations was little incentive for them to go there.

Warpath and Council Fire is a good description of this history. All of the famous battles, including Custer's Last Stand, the Massacre at Sand Creek, and the Battle of the Washita, are vividly described. Almost all of the outstanding figures of Indian history are included in this story. Chief Sitting Bull, Buffalo Bill, Kit Carson, Roman Nose, and Dull Knife are among the many familiar participants in this exciting period of America's growth.

Many of the chiefs really wanted peace with the white men. Stirring Bear, Dull Knife, Crazy Horse and others were willing to work for peace if told what to do. But, they could not understand the white man and the white man could not understand them. This perpetual misunderstanding caused some of the bloodiest battles in history. As an example, on one occasion 30 Army men were killed when trying to catch an Indian who had shot an old, worn-out cow for its hide. The officer in charge was a hot-headed greenhorn who lost his temper and consequently lost his life.

Warpath and Council Fire combines accuracy and interest to make it an exciting account of American history.—*Thellys Hess, '47bus.*

'48 Grads Leave Living Memorial

An unusual war memorial is in the process of being constructed by the graduating seniors—June and August graduates—for 1948.

By-passing bronze or granite as a reminder of a former day, the newest additions to the alumni cast their eyes about for a testimonial to their alma mater that would have few inscriptions, but a greater durability than those left by many past classes.

The result is the War Memorial Scholarship Fund, designed for aid to needy students who have demonstrated the qualities of good citizenship.

Work was begun on the project during the early spring months. Bill Holstein, '48bus, Ponca City, served as chairman of the memorial committee. Philip Rubins, '48eng, Oklahoma City, acted as head for the book drive to raise funds. Marion Smith, '27bus, '48pharm, was named secretary.

Employing the services of volunteers, the graduates to-be organized and carried out a book drive as their major means of fund raising. Old textbooks were collected and resold. Approximately \$1,800 was realized from the first response—enough to insure success for the memorial.

includes seven regular army enlisted men—four master sergeants, two technical sergeants and one buck sergeant.

Unusual in these crowded times is the emphasis O.M.A. places upon "individual instruction" for cadets. Under school rules no class can have a larger enrollment than 25 cadets.

"This fact alone allows the teacher to give individual instruction to each cadet," Ledbetter explains. "This also accounts for the very high scholastic rating attained by O.M.A."
