Elmer M. Million, '35Law, was recently advanced to the position of associate professor at New York University School of Law. He assumed his new duties September 1.

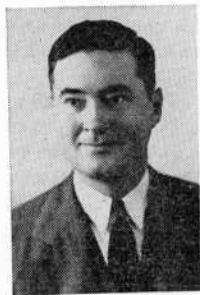
