A Brush with SMU

25 Years Ago

Sooner athletes ran rough shod over the Southern Methodist University Mustangs in three branches of sport in Dallas in 1925 by winning in football, 9-0, tennis, 5-1, and cross-country track, 18-40. Dale Arbuckle, '27Law, '36bs, halfback, now owner of a sporting goods store in Oklahoma City, wrecked havoc with the Mustang passing play by intercepting eight of the Ponies' aerial threats. Ray LeCrone, '31bs, Tulsa, fullback, headed the offense of the Sooners. In 1925 it was reportedly rumored in athletic circles that the Oklahoma-Southern Methodist football game might become an annual affair. We're wondering what Oklahoma would do to the Mustangs' aerial plays now.

Tully Nettleton, '23ba, Oklahoma City, moved to Norman where he became associated with the Holtzschue Motor Company, Willis-Knight and Overland automobile distributors. A graduate of the University school of journalism, Nettleton was with the *Daily Oklahoman* previous to that time. At the University, he served as editor of the *Oklahoma Daily*. No More Chapels

20 Years Ago

Shades of the past—a poll taken in the fall of 1930 found that more students attending the University were the sons and daughters of farmers than of parents engaged in any other trade or profession. We're wondering what the present enrollment statistics would show in the same matter.

Five of the 20 women selected as being outstanding leaders of Oklahoma that year were former University students. They included Mrs. Frances Smith Catron, '26ba, Ponca City; Dr. Lucille S. Blachly, '13bs, Oklahoma City; Dr. Anna Lewis, '30ph.d, Chickasha; Mrs. Walter Ferguson, '07, Tulsa, and Mrs. Maud Calvert, '20ms, Oklahoma City.

National recognition was given the University and especially the school of art when an art collection—valued at \$6,000—was presented it by the Carnegie Corporation. Included in the collection were 26 original etchings by such famous artists as Rembrandt, Millet, Whistler, Corot and Goya. Also included were more than 300 books on art history, biography and philosophy.

After long contemplation, a plan was formulated whereby no more University chapels were held during class hours. Not only was there no place on the campus large enough to handle a chapel, but also it was believed they interfered with effective class work.

Four new fraternity houses were erected that year. They included Phi Kappa Sigma, Pi Kappa Phi, Sigma Mu Sigma and Pi Kappa Alpha.

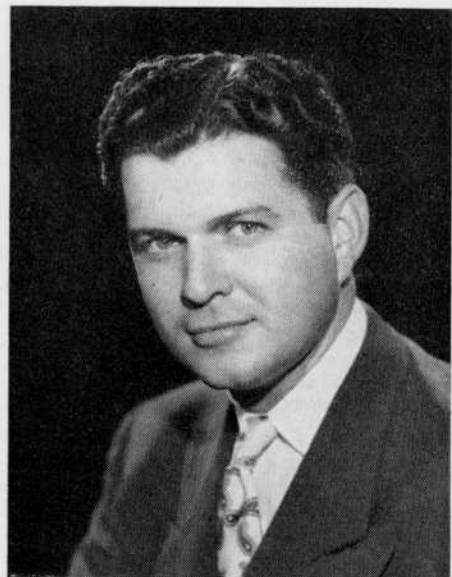

No madness was present in the 1935 Sooner football team's motive when it took 60 gallons of Norman water with it for drinking purposes upon making the trip to Dallas to play the University of Texas Longhorns.
