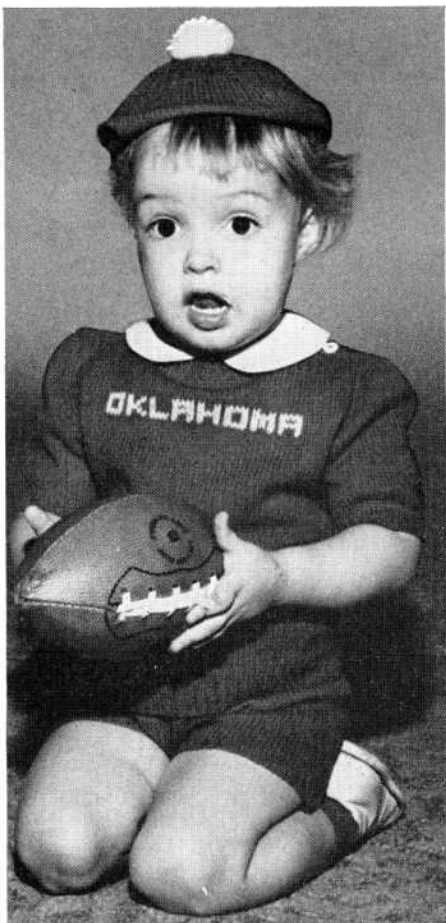
'37 Jack H. Benson, '37Law, formerly of Wichita, Kansas, was transferred by Stanolind Oil and Gas Company to the

Basketball on Rebound

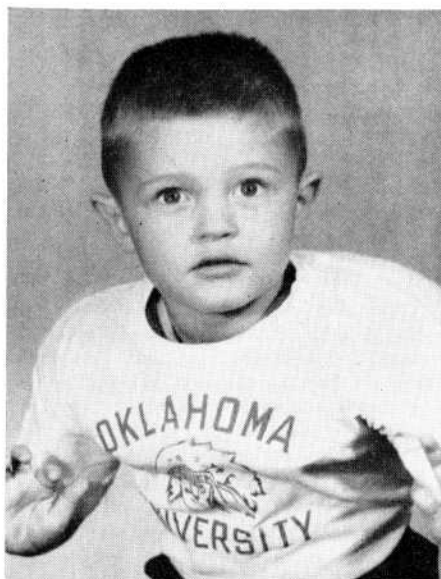
25 Years Ago

Basketball led the sports parade in March 1926—as the University completed the season with nine victories and three defeats for a final percentage of .750. In the closing game of the Missouri Valley, Oklahoma A.&M. defeated the University squad by a score of 29-26, a game apparently as hard-fought as the ones played between the two teams during the 1950-51 season. Although the season was not completed for several of the teams in the conference, only one team boasted of less defeats than Oklahoma, and Coach Hugh McDermott, '20ba, was assured his team would at least tie for second place in the league standing.

Will Rogers Was Here

20 Years Ago

Excerpts from the March 1931 issue of *Sooner Magazine*: Will Rogers, America's most cosmopolitan citizen and the greatest of the Oklahomans, made not only a spiritual but actual contribution to drought relief in the southwest by a flying tour of the district, giving talks and contributing the funds so raised to local relief. He appeared in Norman during the early part of March before an enthusiastic audience of nearly 4,000.

The Oklahoma Ministers convocation in Oklahoma City adopted a resolution seeking the abolishment of compulsory military training at the University and also at Oklahoma A.&M. College. Fifteen different denominations were represented on the passage of the resolution.

Hicks Epton, '31Law, represented the University against the Kent School of Law in debate at Chicago—and as a one-man team, lost a debate not verbal. Out to see the Windy City, Epton was nearing the Commercial Mart when a Chicago citizen stepped up to him at 11:00 in the morning.

"Change for a quarter?"

"No, I'm sorry."

"Well, give me what you have then," replied the host.

A gun in the host's hands decided Epton. He forked over his expense money, \$22, and his railroad ticket.

"How about letting me keep a couple of dollars?" Epton asked.

"Thirty cents is enough for you," replied the bandit. Finally, he did return the railroad ticket. Epton is an attorney in Wewoka.

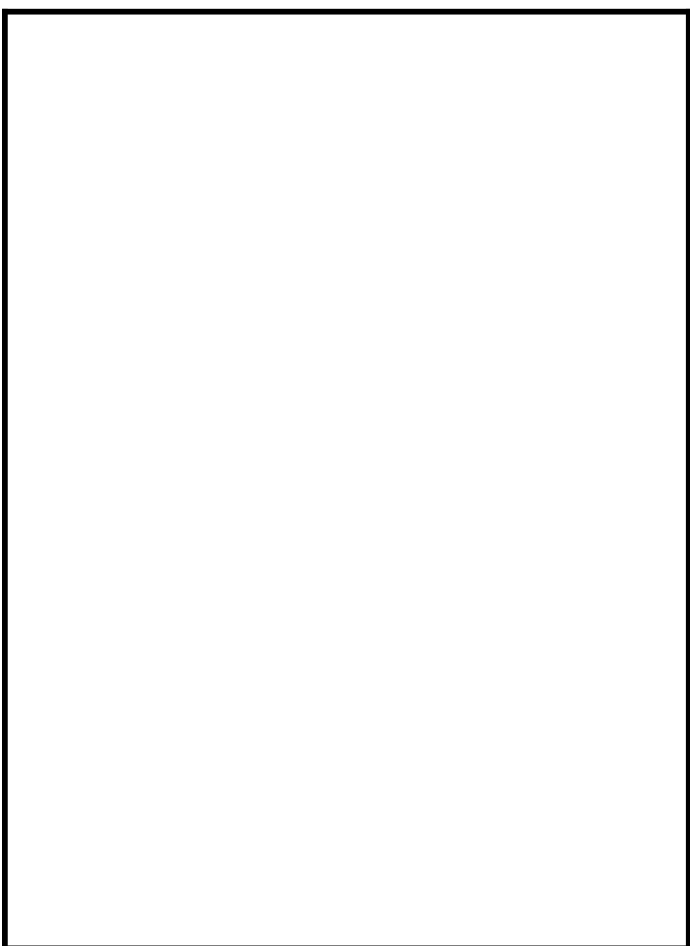
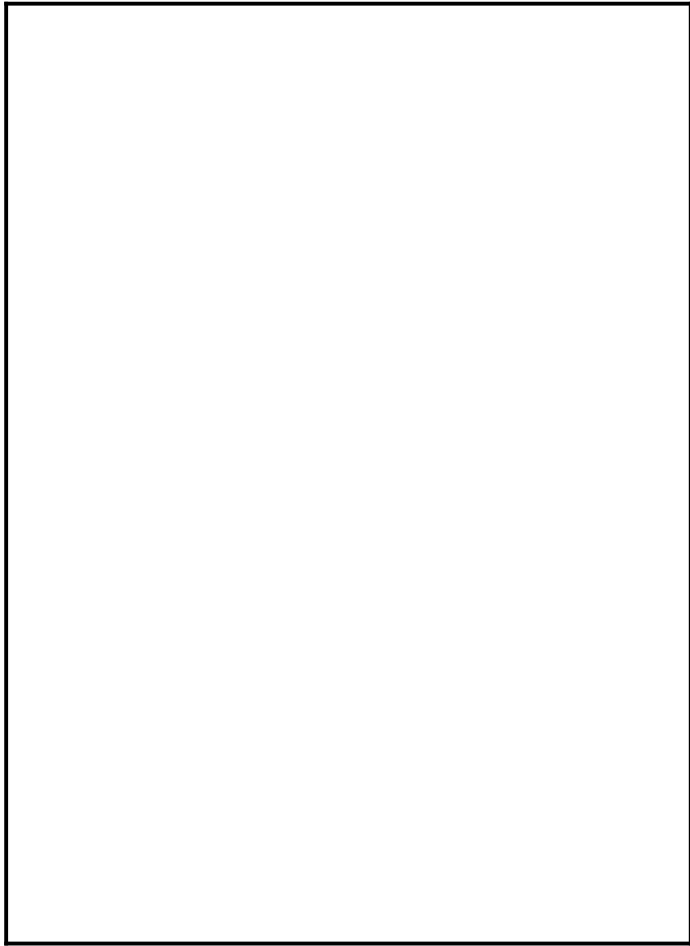

An Investigation

10 Years Ago

Shades of the past—and of the present. March 1941 issue of *Sooner Magazine* reported a group of University faculty members who had taken an interest in activities to protect civil rights were subpoenaed to appear before a Senate committee investigating subversive movements in the state. Much of the steam was taken out of the investigation when University administrators revealed that members of the FBI had been on the campus since May of the previous year looking into reports of alleged communistic activity, although their reports had revealed nothing.

Enrolment was dropping at the University at an alarming rate—a parallel to the situation existing on the campus today. Some 25 applications a day for transcripts of grades for students and alumni interested in entering the various branches of military service were recorded. The office of Admissions and Records estimated that approximately 300 students left the campus during the first semester of the 1940-41 school year to enlist.

In covering the campus—Old Copenhagen, veteran jumper in the R.O.T.C. stables at the University, and well known to many alumni and former students, reached the end of the road in May 1941. He became so feeble that it was decided he would have to be shot. However, "Cope" died quietly before the coup de grace could be administered. A grave was dug near the polo field and "Cope" was buried with military honors befitting his 25-year record.

Student grade reports for the first semester include a total of 2,118 F's and the registry office reported that professors attributed most of the failing grades to "lack of study and application."

of the research is made possible through industrial fellowships.

Peter A. MacQueen of Silver Creek, Colorado, holds a Sinclair Refining Company fellowship. The studies by MacQueen are on the effect of connate water saturation on the ultimate recovery of oil by water flood operations.

The Stanolind Oil and Gas Fellowship is held by Gustav Stoltz, Jr., Victoria, Texas. His research is the measurement of the capillary pressures of natural and artificial core plugs by various methods including the porous diaphragm, the mercury injection, and lowering vapor pressure. It is

expected that a further correlation of the factors involved and the absolute permeability of the core plugs can be obtained.

The Shell Oil Company Fellowship is held by David T. Oakes, '48eng, Norman, Oklahoma. He is carrying on an investigation of drilling fluid behavior for the purpose of establishing the effect of various electrolytes on the electrokinetic or particle potential, and the viscosity and water loss of Bentonite dispersions.

His specific research is directed toward determining whether there is any fundamental difference between the flow in a capillary tube of a single fluid as compared with alternate slugs of different fluids.

Research and Developments

The A.P.I. Research Project 47B has been continued in the School of Petroleum Engineering. A microscopic study of multiphase flow through synthetic porous media will be expanded since additional facilities have become available.

The research activity within the A.P.I.'s Research Project 47B at the University of Oklahoma, which has been devoted to a search for microscopic mechanisms of fluid behavior in porous media, has yielded several interesting developments to date and
