A Former President Dies

End of Service. Tom F. Carey, Sr., '08ba, who served as Alumni president in 1912, four years after he received his degree from the University, died April 5 at his Oklahoma City home.

Death was attributed to a heart attack.

After serving as president of the Alumni organization in 1912, he was re-elected in 1928. During his latter tenure he was instrumental in establishing the *Sooner Magazine*.

At the time of his death he was a trustee of the O.U. Life Membership Fund of the Alumni Association, trustee of the University of Oklahoma Foundation and a member of the Masons, Knights of Pythias and of the Presbyterian Church.

His undergraduate activities included membership in Sigma Nu fraternity, staff member of the yearbook, achievement in oratory and 1908 class president.

A public accountant, Carey was past president of the Oklahoma Society of Certified Public Accountants and a member of several professional organizations including the American Institute of Public Accountants and the Oklahoma City Executives Club.

He is survived by his wife of the home, a daughter, and a son, Tom F. Carey, Jr., '38bs, '40Law, of Tulsa.

The positions have been reported to the *Sooner* by University deans and department chairmen through the cooperation and direction of Frank A. Ives, director of the University Employment Service. Because of deadline problems, some of the jobs may have been filled before this magazine is in alumni hands.)

1. A Tulsa company is interested in hiring a man who has a petroleum engineering background with sufficient experience in drilling to qualify as a top-flight supervisor. He must be familiar with the performances expected from types of equipment now available to the drilling contractor.
