It is not uncommon for a dean or a department chairman but for an assistant dean its practically unheard of. In mid-spring, Dr. Elden S. Magaw, '28ba, '31Law, who serves in the latter capacity for the Temple University School of Law, was present as the Temple Law Alumni Association's presented his portrait to Temple University.

The presentation was no accident. The Law Association wanted to pay their respects to a man, "who has devoted his heart and his life to our law school."

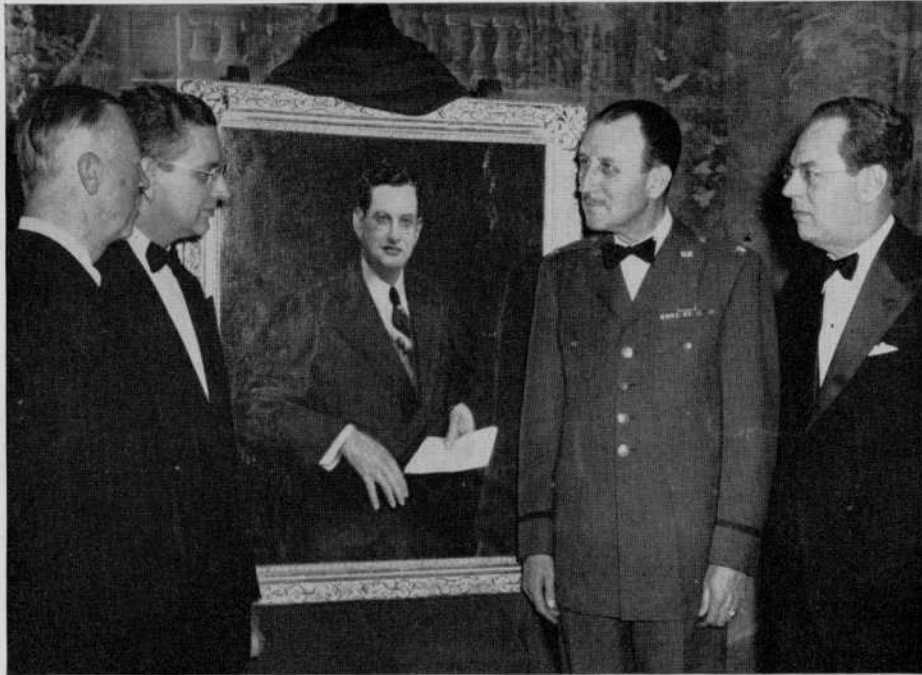
Dr. Magaw practiced law for two years prior to accepting the professorship at Temple in 1933. He was admitted to practice before the Supreme Court of the U. S. in 1941. He has filled his spare time by serving as legal columnist for the *Philadelphia Inquirer* and consultant on legal research to the Coroner of Philadelphia.

In 1949 Magaw made his one and only venture into politics. He was asked to run for burgess of Landsdowne (same as may-

or) on the Democratic ticket in an area roughly 7-1 Republican. If it is possible to be victorious in defeat, Dr. Magaw turned the trick. "It was a pleasant surprise that I was defeated by a vote of less than two to one," he wrote.

He is listed in practically every Who's Who beginning with the international edition and working down to area publications. He has been a member of the Panel of Arbitrators of the American Arbitration Association and for one year was Impartial Chairman of the Adjustment Board at Cramp Shipbuilding Company In Philadelphia.
