

## Harry W. Bass Makes Important Gift to O.U.

ONE OF THE LARGEST gifts ever received by the University of Oklahoma, leading to the creation of what promises to be the outstanding collection of books and documents on the development of American business and industry, has been announced by President George L. Cross.

The \$10,000 gift came from Harry W. Bass, '17, a well-known independent oil and gas producer of Dallas, Texas. Bass, who started his oil career as a cable tool dresser during the Ranger, Texas, boom 36 years ago, heads several drilling, oil producing, gas processing, and pipeline companies, and is president of the Texas Mid-Continent Oil & Gas Association, the state's largest organization of oil and gas producers.

"This important new development at the University will be called the Bass Business History Collection," President Cross said. "It is our intention to gather as complete a library as possible relating to the history of business and industry in this country. Obviously it will have profound importance to our understanding of the contribution of business organizations to our civilization."

Bass, the son of a pioneer Enid family who made the original run in 1893 into the Cherokee Outlet, was a student in the O.U. College of Business Administration, when at the end of his junior year in 1917, he entered the Army. On his return to civilian life, he worked briefly as a bank teller in Enid.

Cashing a check for a tool dresser one day, he discovered a wide gap between his own rate of pay and that of oil field workers. This cast the die for his entry into the oil industry, and he shortly went to work for H. H. Champlin, the oil producer and refiner of Enid.

Bass' career in the petroleum industry has been marked by alertness to new ideas. He built the first portable A-frame derrick to aid in the mobility of drilling operations; he worked out one of the first systems for unitizing a field on an acre-foot basis to increase recovery; he put together a unique operation in the Wilcox Trend area in



South Texas to gather gas; he is regarded as a pioneer in Alberta, Canada, where he moved in his drilling rigs about 15 years ago, long before the current boom there started.

He is president of the Harry Bass Drilling Company, Dallas; the Goliad Corporation, Corpus Christi, and Trinity Gas Corporation, Dallas, natural gasoline plant operations; the Wilcox Trend Gathering System, Inc., Dallas, a natural gas pipeline company; the Can-Tex Company, Calgary, Canada, drilling and producing.

In addition to the book collection just begun, he is the donor of the Robert Dean Bass Scholarships, awarded annually at the University of Oklahoma, in memory of his nephew, who was killed during the Battle of the Bulge in World War II.

The Bass family has long been closely identified with the progress of the University. John Bass, for 30 years an attorney for the Federal Trade Commission, now lives in Norman with his wife, the well-known Oklahoma writer Althea Bass; and Henry B. Bass, the builder, a resident of Enid, is a member of the Board of Directors of the University of Oklahoma Foundation.

nomena of addiction, provides a means of investigating the process of addiction and

its variables in the laboratory, and offers the underlying motive for the commonly used working theory that physical dependence and addiction are related.

One part of Nichols' research was completed. Still in the experimental stage: alcoholism. Would his experiments prove that alcoholism was related to escape training? He will not know for several months. But the work already completed should prove significant. At best it may establish a comprehensive foundation for the study of addiction—a contribution to knowledge through research by a University of Oklahoma graduate student.
