1910

Earl Q. Gray, '10ba, Ardmore attorney, was appointed to the Oklahoma Securities Commission on January 9 by Governor Raymond Gary. Gray will serve as one of three members on the board. He is immediate past president of the Oklahoma Bar Association.

Fred E. Tarman, '10ba, publisher of the *Norman (Okla.) Transcript*, won second place in the editorial and column-writing contest sponsored by the Oklahoma Press Association and Oklahoma Natural Gas Company in November. Winner for the second time in two years, Tarman was awarded a \$25 savings bond for his editorial "Arrested Speeders Should Not Squawk."

1911

Ernest L. Lambert, '11, now in the oil investment business at Okmulgee, has been chosen on the Helms Foundation All-American Team. He was selected on the team of 1910. Lambert played for Oklahoma's all-victorious 1910 club, coached

by Bennie Owen, that won the Southwestern championship after clobbering Texas twice at Norman.

1913

Dr. W. Kelly West, '13bs, '15med, Oklahoma City physician, was installed as president of Southern Medical Association November 14, in Miami Beach, Florida. This meeting of the association was the largest in its history; more than 3,000 physicians attended.

1914

Fritz L. Aurin, '14, Fort Worth, Texas, retired in January from duties as executive vice president of Southland Royalty Company after completing 25 years of service with the firm. He formerly served as president, and plans to stay on as director and consulting geologist. He is also a past vice president and chief geologist of Marland Oil Company.

DEATH: Mrs. Joe C. Love (the former Jennie Gladys Williams, '14), Purcell, died October 17,

1957, at the age of 64. A pioneer resident of Purcell, Mrs. Love was active in civic, social and church affairs of the community.

W. P. Lively, '16ba, retired supply officer of the Veterans Administration Hospital in Lexington, Kentucky, represented the University of Oklahoma at the September 24, 1957, inauguration of the University of Kentucky's new president, Dr. Frank G. Dickey.

Col. Bennett H. Griffin, '17ba, planned to retire February 1 from duties as director of the Washington, D. C., National Airport. Griffin, 62, has been in government service 26 years, and director of the airport since 1947. A pilot who set a flight record from the U. S. to Berlin, Germany, in 1932, he now plans to enter private business in the Washington aviation industry.

Wyatt Marrs, '17ba, Norman, has written a new

book, *The Man on Your Back*, published by the University of Oklahoma Press in its Spring, 1958, list. The book, described as "a preface to the art of living without producing in modern society," deals with social parasitism, society's most deadly enemy. Marrs is a professor of sociology at the University, and he holds a master's degree from the University of Chicago.

FOOTBALL TICKETS

Alumni who are not season football ticket holders should watch for a card from the Athletic Business Office in February. This card must be returned by March 15, if you want a ticket order blank on your alumni priority. The procedure is as follows:

All paid members of the Alumni Association will be mailed a form on which they may indicate the football tickets they wish to purchase in 1958. These inquiries will be mailed from Norman by February 15 and must be returned by March 15.

On April 1, football tickets order blanks are mailed to all paid alumni who have replied. (The order blanks are mailed automatically to all season ticket holders whether they are alumni or not.)

Send no money in February—you merely exercise your alumni priority and request an order blank.

If you purchased season tickets for the 1957 season, you will automatically receive a re-order blank in April. You can ignore the February inquiry.

If you did not buy season tickets in 1957 and want tickets to any of the 1958 games, return the February card. If you are in this category and do not hear from the Athletic Business Office in February, write that office a card requesting the order blanks.

This is the same system of football ticket distribution as that used last year. We hope every alumnus can see the Sooners play in 1958.

CHANGE IN COMMAND

WHEN REINS ARE PASSED from one pair of hands to another, then it's time for one party to look forward, while the other looks back. Two University of Oklahoma alumni are now doing just that.

Oklahoma College for Women in Chickasha noted a change in command on February 1. Dr. Dan Procter, president of the school for more than 14 years, passed the reins to Dr. Freeman Beets, one of the most popular faculty members at OCW. Both are O. U. graduates.

Procter, '36m.ed, '43d.ed, was a good head man, famed for his lectures filled with hard-hitting truth and insight. "(He) can 'lay it on the line' with emphasis," a Kansas City businessman told the U. S. Chamber of Commerce, "and he has a real appreciation of human values as well as community values." The *Oklahoma City Capitol Hill Beacon* called him a "master raconteur whose timing is unsurpassed by contemporary topflight platform artists."

During the past year he spoke at more than 60 engagements in Oklahoma, and to state and national organizations in ten other states and Canada.

He served as president of the Oklahoma Education Association, was a member of the State Board of Education and State Teacher Retirement Board, and in 1951 was made a director of the University of Oklahoma Alumni Association. He worked with the Boy Scouts, and won the DeMolay Legion of Honor Award. In 1943 O. U.'s College of Education faculty voted him the outstanding graduate student.

So many civic groups and charity drives find Procter listed in their executive rolls, that it is impossible to name them all here. Future plans? Procter moves into the position of vice president in charge of public relations for Star Engraving and Manufacturing Company, Houston, Texas.

Freeman Beets, '48ma, '54d.ed, is 38 years old, was born and educated in Oklahoma, and recalls that his first job was that of carrier boy for the *Chickasha Daily Express* newspaper.

Several years ago he worked as assistant executive secretary, education commission of Southern Baptist Convention in Nashville, Tennessee. In this capacity he made a socio-economic study of potentialities of three Georgia Baptist junior colleges. Later he did the same for the church's colleges in Houston, Texas, and Atlanta, Georgia. He was a consultant for numerous schools in administrative and academic matters.

Emerging from World War II service with the Purple Heart and Bronze Star, he taught at Oklahoma Baptist University, then directed the night school, then headed the departments of business and journalism.

He was director of admissions and registrar for Hardin-Simmons University in Abilene, Texas, when OCW tapped him for teaching. For the past 18 months, he has instructed in journalism and English, and been assistant to Procter.

Beets is married to the former Margie Elizabeth Edwards, also a graduate of O. U.
