Harry L. S. Halley, '15ba, 17Law, State Supreme Court Justice, was the principal speaker in Norman for the Central Southwestern Province convention of Sigma Chi fraternity. Attending the convention were members of Sigma Chi chapters from nine universities in Oklahoma, Arkansas, and Texas.
