Alex McCoy, '40geol, the boy who didn't look at the birdie in last month's Roy E. Heffner photograph, was an easy person for alumni to recognize. His weariness should be easy to recognize also: he had just been through a lengthy initiation ceremony with his Phi Delta Theta pledge class, and he was facing a jolly round of frat songs.

The pose Heffner caught in his formal (except for McCoy) picture is evidently a unique one of Tulsa's busy Mr. McCoy. In 1953, after a spectacular rise in the geology divisions of Carter, Phillips and Gulf oil companies, McCoy organized McCoy Associates, Inc., his own company, now employing 40 geologists and engineers, and serving customers throughout the world.

When he is not flying to company offices in Casper, Calgary, or Denver, McCoy attempts to work in a little golfing and fishing. But these attempts understandably have to take second place to a home life involving his wife, Shirley (a University of Southern California graduate) and eight children: five girls and three prospective Phi Delts.

1906-1929


