"You Will Never Lose Track of Me"

IN 1916 C. Curry Bell took pen in hand with the rest of his graduating class and filled in an alumni information blank. The last question read: "Give name and address of one or more of your friends or relatives who can inform us of your where-

abouts if we ever lose track of you."

Bell scrawled: "You will never lose track of me."

He was as good as his word. When Bell died October 9, the University lost not only one of its most distinguished graduates, but also one of its most staunch supporters.

Bell went to St. Paul, Minn., after taking a degree from Chicago's Rush Medical College and interning in Cincinnati. Though he spent the remainder of his life in St. Paul, he was as close to O.U. as the nearest post office.

He organized an alumni club in St. Paul and was its first president. In 1923 when O.U. President Stratton D. Brooks became a political fast-shuffle victim of Governor Jack Walton, Dr. Bell protested in a letter to the University: "Political tampering with our educational system shows mainly the serious need of education in Oklahoma."

The next year an alumni directory was published. Dr. Bell, shocked to see several fellow doctors on the "whereabouts unknown" list, sat down with the directory of the American Medical Association and made certain that O.U. didn't "lose track" of his colleagues either.

Dr. Bell's brother, John Bell, '15ba, with the Bureau of the Census in Washington, D. C., died in 1953. Curry Bell had followed John to O.U. after graduation from

University Preparatory School at Tonkawa (now Northern Oklahoma Junior College). Both were Sigma Nu fraternity men and on the varsity football and basketball teams.

Curry Bell also served on the Athletic Council, Student Council, Inter-fraternity Council, Tabasco Board, Sooner Yearbook staff and was a member of Phi Beta Pi medical fraternity.

The St. Paul Alumni Club ran out of steam somewhere along the years, but in 1955 Dr. Bell, at the age of 67, agreed to bring his roster up-to-date and head a revived group.

He and his wife Violet sent their youngest son, Richard Johnson Bell, to O.U. in 1951. Three other children, Mrs. Nancy Benton, Charles Curry III and John Montgomery Bell, all attended the University of Minnesota.

Dr. Bell's work in numerous medical associations, on the staffs of four hospitals and as trustee of the Ramsey County (Minn.) unit of the American Cancer Society was abruptly ended when he himself developed cancer of the lung.

As he visited during his brief illness with his three sisters, Annie E. Bell, Josephine Bell and Mary R. Bell, all of Oklahoma City, one of his favorite topics of conversation was this year's outlook—in detail—for the Big Red.
