The January Sooner was hardly in the mail before identifications of the Heffner tennis players began to roll in. Everyone knew Ed Overholser, Jr., '28-'31, and all but two correctly tagged the late Harold C. Thurman, '32ba, '32Law.

John W. Brand, '35bus, Tulsa, who was also out for tennis that 1930-31 season, came forth with the information that Thurman was team captain, while Overholser was captain-elect. Other racket wielders of the day were Crawford Bennett, '32ba, '32Law, Lowe Runkle, '30ba, and Archie McColl, '27-'30. Dr. John O. Mosley was the coach.

Jack O. Stone, '31ba, now in advertising and public relations in Lubbock, Texas, remembered the Sooner players from the many lines he wrote about them while with the Daily Oklahoman and Oklahoma City

Ed Overholser is still active in state tennis circles and has become quite a handball player since college days. The son of one of Oklahoma City's early mayors, Overholser was a member of Phi Delta Theta. He left O.U. to work for Braniff Insurance company in Oklahoma City and is now court bailiff for Oklahoma County's Judge Bruno Miller. Mr. and Mrs. Overholser live in Edmond. They have a daughter, Mrs. Scott Russell of Kansas City, Kansas.

Harold Thurman's home was in Dallas at the time of his death, June 20, 1944. He and his father, the late Judge Hal Thur-

man, had moved their practice to Dallas from Oklahoma City. Thurman was president of his fraternity, Sigma Nu, and was a member of Tri Chi and the "O" Club. A three-letter man, he remained active in tennis competition for several years after his graduation.
