## Sooner Scene

The idea of a "University of Oklahoma Day" sponsored by an alumni club, and sometimes jointly sponsored by a civic club or Chamber of Commerce, has proved to be a very successful way of getting alumni together and of providing a forum for relling the O.U. story.

The idea for an outstanding meeting of this type originated with Mr. Julian Rothbaum, Regent of the University and an O.U. alumnus. Rothbaum organized a committee consisting of Ellis Gable, member of the Regents for Higher Education, L. B. Selman, Tulsa insurance man who was recently elected to the Alumni Executive Board, Judge Royce Savage, Ralph K. Bogart and Richard L. Jones, president of the Tulsa Chamber of Commerce. The outcome of their planning was the most impressive alumni meeting ever held in Tulsa.

Here are some of the highlights of this occasion. On the morning of May 10th, a regular meeting of the University of Oklahoma Regents was held in Tulsa. During the afternoon a meeting was held of the O.U. Alumni Executive Board at which time the forthcoming Oklahoma college building bond issue was discussed. A lunchcon was held in the Grand Ballroom of the Mayo Hotel at which an overflow crowd of alumni was present. L. B. Selman, representing both the Chamber of Commerce and the O.U. alumni, presided at this fine occasion. The speakers of the day were President G. L. Cross and Coach Bud Wilkinson.

Civic leaders of Tulsa and O.U. alumni attended a reception Monday afternoon as guests of Regents Leonard H. Savage, Oklahoma City; Julian Rothbaum, Tulsa, and District Judge Royce Savage, Tulsa. The other Regents who attended throughout the ceremonies were Dave Morgan, Blackwell; W. D. Grisso, Oklahoma City; Glenn Northcutt, Willis, and Regent President T. R. Benedum, Norman.
