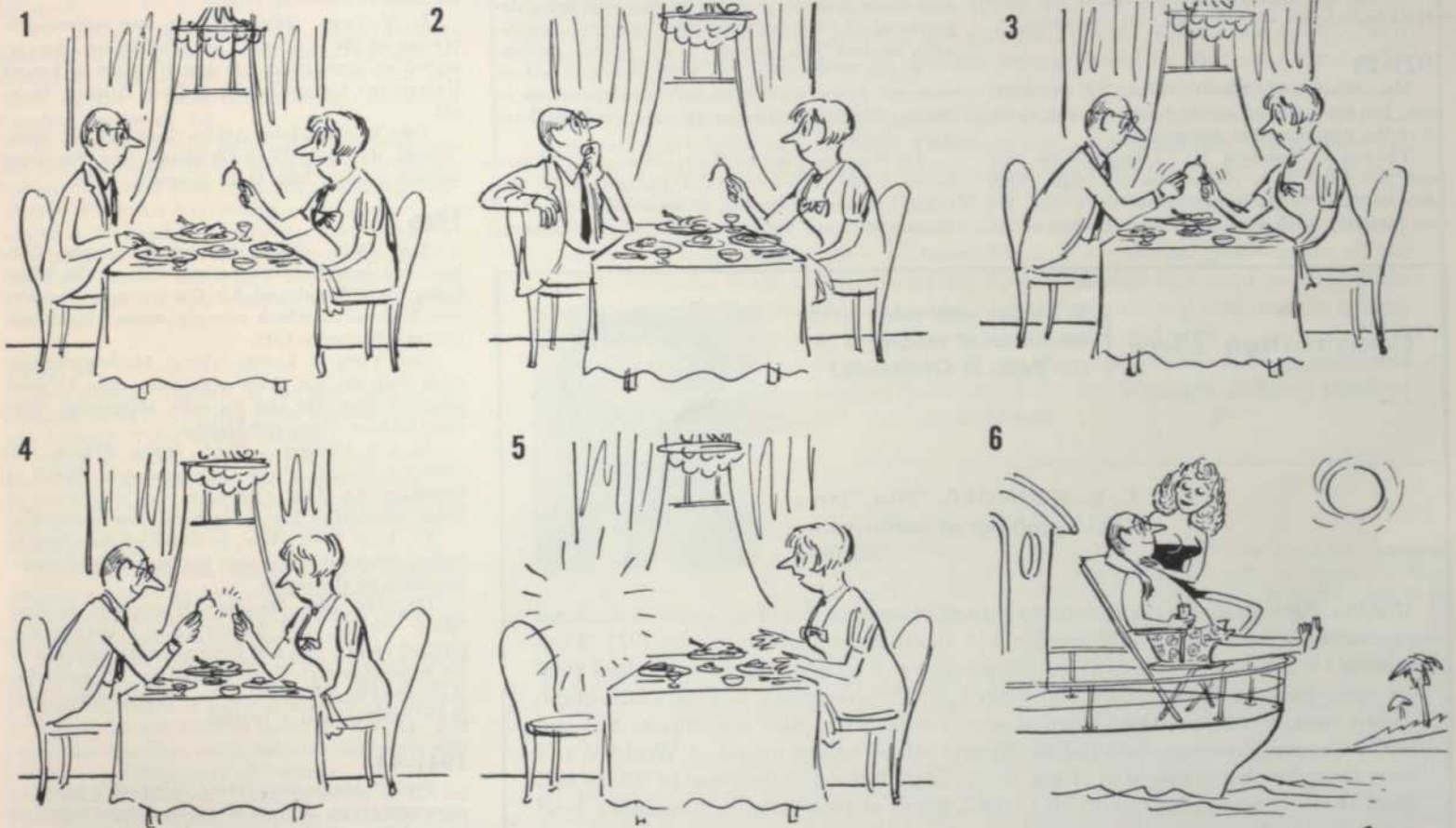

Conversation Piece

What are your most vivid memories of your days in the Pride of Oklahoma?

C. E. SPRINGER, '25ba, '26ma
O.U. professor of mathematics
Norman



SPRINGER—Probably the first thing I think of as an outstanding event in my band experience is the trip to the Nebraska-O.U. football game at Lincoln in 1921. They beat us 44 to 0. On the football field it was about 4 inches deep in mud. And then we came back by Kansas City and played for the American Legion Convention. There were 36 of us—6-by-6—and it was a wild affair that convention. General Foch, General Pershing, Admiral Beatty and other famous people of World War I were there for that occasion . . . I was a part-time director of the band in '25-'26 and don't think it was called the Pride of Oklahoma at that time. . . One other fond memory was that of the year in which one Lucile Farmer was sponsor of the band. We called them "sponsors" then and not "queens." She is now my wife . . . There really was a lot of loyalty among band members. Nowadays if one tuba player doesn't show up there are five or six others. But in our day we had one tuba player and he had the responsibility. He just felt he had to be there to make the show go. . . What the association with other band members meant to me came home strikingly when we established the Alumni Band Association. That first year some men came back for Homecoming whom I hadn't seen for over 35 years. It was a very touching event. It is interesting to see how much fun they actually get out of it. And I go along with them; I enjoy it very much . . . I could name a good many friends over the state and over the country whom I played with for several years. When I went to Oxford, I played the sousaphone. I wasn't able to continue on the trumpet because of difficulty of keeping up the embouchure. I was invited to play with the dance band there—the Bandits they called them. Of course that was an experience I never would have had if I hadn't had the experience of music here on the campus.

What are your most vivid memories of your days in the Pride of Oklahoma?

WEACH—I remember the reaction of the audiences wherever we played, both concert and on the field. We were well received everywhere we went. That is probably one reason they call the band the Pride of Oklahoma—because we were very outstanding both in concert and on the field. . . The benefits of playing in the band are pretty similar to playing on a football team or any sport for that matter. You learn team work. You learn to get along with others. And you also—believe it or not—learn sportsmanship. You learn to coordinate yourself with other people in an organization like that. . . Of course, I was a major in music when I was at O.U., and probably more interested than the average person would be. But even those who weren't majoring in music had a surprising pride in being with that organization. . . The Alumni Band at Homecoming gives me a chance to go back and see the campus again and just relieve the old days, you might say. . . And another thing, there are about 15 or 20 of the fellows there that I ran around with quite a bit when I was in school and this is the only chance I get to see them. Some years one or two won't be there but the next year they will be. It's just an old get-together—kind of a family reunion. . . These friends last a lifetime. We had a common goal—to do all we could to keep the Pride of Oklahoma the Pride of Oklahoma—and to make it an even better band. You would be surprised at those who are still interested in it, who still want it to be better even though they are not connected with it. . . the enthusiasm is still there. . . I had subjects down there other than the band. I was interested in all of them, you know, but the band was really the highlight. When I think of the University of Oklahoma, I think of that band.

What are your most vivid memories of your days in the Pride of Oklahoma?

RORSCHACH—Most of all I remember my feeling of contributing to the spirit and enthusiasm of the student body. I think all the band members had a pride in belonging to the band—drilling and working to be a part of the ceremonies and activities that highlighted the home games. We also tried to take a lot of pep and enthusiasm to the games that the band attended away from home . . . I have vivid recollections of the trips we took to Dallas every year. We did take one trip to Columbia. On that particular trip the train was late. We arrived just about the time the game was starting, but we had time to give the team some pep and to create a little atmosphere at the game . . . I was a member of the band from '26 to '31. It was about that time that we took the name "Pride of Oklahoma" . . . I think that probably Mr. Wehrend was the person who originated that name. I was business manager of the band in '30 and president in '31. That was the year that we got our uniforms—the same style uniforms that they have today. I helped raise money to buy those uniforms—the first ones we had. I think we bought 60 at that time . . . I really have enjoyed participation in the Alumni Band. We get to see our old classmates and also we get such a kick out of playing again.

What are your most vivid memories of your days in the Pride of Oklahoma?

MORGAN—Ever since I left the band and while I was with the band, I've thought it was a very fine one. It is always worth while going to hear it . . . Whether the football team is winning or not, the band is All-American every time . . . I played one year in '35-'36, then I was away for a year and played about two or three years after that . . . We took several trips. I remember one year, I believe it was 1938, I was able to see all the conference games—at that time it was the Big Six.
