

## Conversation Piece

As a former O.U. student, what is your interpretation of academic freedom?





MRS. FERRIS—Academic freedom, like freedom of the press, is a democratic right. And, like all democratic processes, it carries with it personal responsibility . . . Having been a member of the American Association of University Professors for the past two decades, I have watched with interest the hundreds of cases in which professors have been reprimanded by their institutions for alleged violations of academic responsibility, and those in which university and college administrations have been censured for denial of academic freedom . . . Freedom of speech is not a one-way street. Neither is citizenship. The 1940 Statement of Principles of the AAUP emphasizes that faculty members also are citizens, and in the expression of their opinions, should be accorded the same freedom accorded by law to all citizens. I concur . . . I am glad that I attended the University of Oklahoma where academic freedom prevails, and my professors were entitled to speak their opinions. I did not always agree with them, but my horizons widened, and I learned. I believe this is the purpose of a college education.

This profession, directly or indirectly, has the tremendous responsibility of molding future generations. For this reason, such freedom must be acted upon by the profession in utmost good faith . . . If such action by the professor is clothed with selfish gains in any manner and not for the advancement of our principles, ideals and code of ethics, then the university should, with a similar limitation, control such individual act . . . In either event, the best judge for the use of such freedom should be the conscience of the professor.





As a former O.U. student, what is your interpretation of academic freedom?





GUTHREY—Academic freedom is one of the by-products of democracy. As with any freedom we enjoy, there is accompanying responsibility . . . Any university teacher is in a unique position to influence young minds in various stages of maturation and sophistication. His words and writings will be a reflection of his institution and his own profession. Within this framework of responsibility and propriety, the teacher should have the utmost freedom to present his facts and opinions. We would hope that his public utterances are factually based within his professional knowledge . . . Obviously, as citizens we are guaranteed "free speech" upon any subject. In my opinion and observation, the most progressive and respected institutions are those in which there is minimal academic restriction of the faculty. A professor's primary obligation is to his students. Loyalty to his institution and himself should be of secondary importance . . . This should not exclude controversy, which stimulates thought, facilitates learning and can lead to effective action.



Conversation Piece

As a former O.U. student, what is your interpretation of academic freedom?





ADAMS—As a facet of the question of academic freedom, discussion of individual license to express personal opinion publicly first requires specification of the particular individual's function in the institution. This identification is essential in examining the only apparent problem-whether a personal opinion can reasonably be interpreted as the official policy of the university on any issue . . . Although faculty appointment alone certainly warrants respect, such appointment hardly constitutes designation as policy-maker for the university. Since the majority of faculty members serve the university directly only through teaching and research, the assumption that university policy is expressed in one professor's statement is, in general, absurd. Such a generalization is equivalent to assuming that, because one baseball player endorses a particular breakfast cereal, major league rules require all players to eat that product . . . A high degree of discretion must, however, be exercised by faculty members who occupy administrative positions with decisionmaking authority. Their opinions do directly contribute to university policy on any particular issue. If, by objective examination of any statement to be made publicly, such an administrator finds the opinion to be more closely associated with his official identity than with his individual citizenship, he must subject himself to self-censorship . . . Prudence would seem to dictate that, in any case, the individual should preface his personal opinions by a statement identifying them as such if there is any possibility of misunderstanding. It certainly does not seem unreasonable that the institution itself should request such distinct labeling of public statements, particularly those of faculty members in administrative positions . . . Obviously the university cannot resort to general censorship of the faculty; such suppression of personal expression contradicts a basic purpose of education—the utilization of learning in all areas of human concern. If those who have the most extensive academic backgrounds are denied complete exercise of individual freedom of expression, the value of the educational system and the society which fosters it is in doubt . . . Academic qualifications do not preclude a desire for acceptance of all the opportunities of citizenship.
