**ERWIN**—My first view of the University was on a September evening in 1906 when there were only three substantial buildings on the campus—the old Administration Building, the old Science Hall and the Carnegie Library. They looked attractive to a country boy turned country school teacher who had completed less than one year of the "prep" or high school work. Probably I was most attracted to the library building, as I liked to read most any kind of book. The campus was neat and new but gave the restful setting for a new university where my three older brothers previously had been students and where two of them graduated. The atmosphere of a school of learning was made more impressive by the personal interest and careful teaching of the corps of instructors on the faculty. As a necessary side issue, I had the opportunity to work and read in the library for four and one-half years, thereby satisfying my love for the best in literature. My first and last impressions of the University have been good; so good, that I married a University graduate, and my three sons all have both academic and professional degrees from the University of Oklahoma.

**MRS. CARPENTER**—Since I came from Wisconsin to the University of Oklahoma sight unseen, I was a bit awed by its size. I had decided against attending the University of Wisconsin, because it was too big and impersonal. My awe rapidly gave way to delight when I discovered that, in spite of its size, the Oklahoma campus had a distinctly warm and intimate feeling. This outgoing campus personality was not just the physical campus but the result of students who were enthusiastic and proud of O.U. The only real problem that I encountered was a language barrier—the Southwesterners couldn't understand my clipped Yankee accent, nor could I understand their Southern draws. This situation resulted in some fairly ambiguous conversations. The most lasting impression that I have of my first days at O.U. is the sincerity and friendliness of the students. Their concern for others is by far the most important lesson I learned while at the University.

**HESTER**—I attended the Colorado School of Mines in Golden, Colorado, before coming to O.U., so I already had some impressions of college life. Here amidst an atmosphere of leftover Navy and military efficiency, we learned lines, performed plays, designed costumes, scenery and light plots, and somehow managed to spin an occasional illusion. Our self-imposed exile from the joys of normal college life was a perfect training ground for the classical theatrical requirements, “a bare board and a passion.” The University, in association with the United States Navy, provided the bare board, and the rest was up to us. . .
